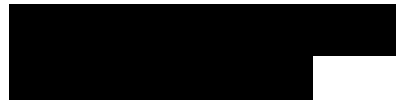

On behalf of all who want to see renters and their neighbors thrive in San Jose, I BEG you not to remove minimum parking mandates.

Mostly I'm a friend of Catalyze SV, but I very much am not when they, (who I bet have ample parking where they live) want to make life for renters SO STRESSFUL!

Please imagine what it's like to be 3 people sharing a 2-bedroom apartment all of whom have to work (not an unusual situation given rents in SJ) Under current conditions, one of them can rent a garage spot, one can usually park outdoors in the open parking, and one will have to park blocks way in front of a neighbor's house or illegally and just pray they don't get fined or broken into. That makes life so difficult for people who are already working hard!

In addition, the current apartment parking allotment assumes all renters have no friends or family, that no one ever spends the night or visits.

And it makes their neighbors in single family houses hate them and resent the fact that apartments are built nearby because sure enough, some desperate renter takes a space they usually have and makes life more stressful for *them*.

The only other options left to renters are to take Uber everywhere which represents a massive tax of \$600/month (My daughter was paying \$30/day to commute four miles) or ask renters to give up three *or more* hours of their lives each weekday moving from bus to light rail, or bus to bus in order to get to and from work.

Don't punish renters for our region's public transit failures. Don't ask them to do what you yourselves would find unbearable.
