#### **RECOMMENDATION**

Deny the appeal from Thomas McInnis (Requestor) regarding the City's response to his Public Records Act request.

#### **BACKGROUND**

On November 16, 2023, the City received a Public Records Act request from the Requestor, in which he asked for: "...any and all vehicle postings, notes, files, reports, testimony, emails, texts, voicemails, documents, and photographs, and dash cams or body cam videos and any other information or legal justification pertaining to this illegal tow of my vehicle(s) by SJPD Badge #4867 and Case # 23-317-0492 and permit # 23-931. Also provide me with the name of SJPD Badge #4867 and all pages of Case #23-317-0492 and all pages of permit # 23-931." This request was routed to the Department of Transportation and the Office of the Independent Police Auditor, then finally forwarded for appropriate processing to the San José Police Department (SJPD) on April 12, 2024. This request is attached as **Exhibit A**. This request was clarified after a series of back-and-forth communications from May 16, 2024 to May 17, 2024.

On May 17, 2024, SJPD responded to the request by providing the name of the requested badge number, and offering to provide a synopsis of the tow event. SJPD also withheld remaining responsive records as records of investigation under California Government Code §§ 7923.600(a) and 7923.605(a). This response is attached as **Exhibit B**. The Requester later requested and received the synopsis of the tow.

On June 3, 2024, SJPD confirmed possession of a California Highway Patrol (CHP) 180 form as responsive to the request and asserted it was exempt pursuant to *County of Los Angeles v. Superior Court* (2015) 242 Cal.App.4th 475. SJPD also reiterated that the requested records were exempt as investigative files under California Government Code §§ 7923.600 and 7923.605. On June 12, 2024, the Requestor appealed the June 3, 2024 response to the Open Government Manager. This appeal is attached as **Exhibit D**.

On September 19, 2024, the Open Government Manager closed the appeal, confirming one of the requested records is a record of investigation under California Government Code §§ 7923.600 and 7923.605 and may be withheld from disclosure. Additionally, the Open Government Manager confirmed the CHP 180 form was exempt from disclosure; however, this appeal letter noted that staff should have asserted its exemption under California Government Code § 7927.705, as a record exempt under state law (i.e., the aforementioned case law). This appeal response letter is attached as **Exhibit E**.

On September 24, 2024, the Requester indicated his desire to appeal this letter response from the Open Government Manager. This second appeal is attached as **Exhibit F**. Staff recently clarified it only possesses body worn camera footage, along with the CHP 180 form, and both are being withheld pursuant to this particular request and appeal. SJPD does not possess any additional requested records. Additionally, the Requestor has made several Public Records Act requests to the City, including SJPD and the Department of Transportation, related to this tow incident. This appeal is limited to the SJPD request discussed above.

### **ANALYSIS**

The Requestor is appealing the City's decision to withhold the body worn camera footage and the CHP 180 form.

Records of investigations conducted by a local police agency, or investigatory files complied by a local police agency, may be withheld under California Government Code § 7923.600. Certain types of information relating to specifically listed crimes, housed in these otherwise exempt records, must be disclosed to certain recipients as listed in California Government Code § 7923.605, except where disclosure would endanger the completion of an investigation. These specific crimes are limited to arson, burglary, fire, explosion, larceny, robbery, carjacking, vandalism, vehicle theft, or a crime as defined by § 13951(b) (California Government Code § 7923.605(a)). SJPD confirmed the underlying incident was logged as a parking violation, and no qualifying "crime" or "incident" occurred. SJPD advised that both the body worn camera footage and CHP 180 form remain categorized as investigatory files, which may be withheld under California Government Code § 7923.600.

California Government Code § 7927.705 permits an agency to withhold a record that is exempted or prohibited from disclosure under state or federal law. CHP 180 forms are exempt under the Public Records Act because they contain personal information pulled from records belonging to the California Department of Motor Vehicles, and this information can only be retrieved by statutorily authorized agencies (i.e., law

enforcement) (County of Los Angeles v. Superior Court (2015) 242 Cal.App.4th 275, 484)).

Based on the foregoing, the Administration recommends the Rules and Open Government Committee uphold the Open Government Manager's decision on appeal to continue SJPD's withholding of the relevant records pertaining to the request for tow records.



The Public Records Request referenced below was forwarded to the Research & Development Unit of the San Jose Police Department on April 12, 2024 for processing. Please find the following response to your request:

**Request**: This is a public records request to supply me with any and all vehicle postings, notes, files, reports, testimony, emails, texts, voicemails, documents, and photographs, and dash cams and or body cam videos and any other information or legal justification pertaining to this illegal tow of my vehicle(s) by SJPD Badge # 4867 and Case # 23-317-0492 and permit # 23-931. Also provide me with the name of SJPD Badge # 4867 and all pages of Case # 23-317-0492 and all pages of permit # 23-931.

**SJPD Response:** The name of SJPD Badge #4867 is Fihussein Elie. The requested records are considered records of investigation and are exempt from public disclosure pursuant to California Government Code 7923.600(a). California Government Code 7923.605(a) details to whom records of investigation can be provided.

- (a) Notwithstanding Section 7923.600, a state or local law enforcement agency shall disclose the names and addresses of persons involved in, or witnesses other than confidential informants to, the incident, the description of any property involved, the date, time, and location of the incident, all diagrams, statements of the parties involved in the incident, the statements of all witnesses, other than confidential informants, to the victims of an incident, or an authorized representative thereof, an insurance carrier against which a claim has been or might be made, and any person suffering bodily injury or property damage or loss, as the result of the incident caused by arson, burglary, fire, explosion, larceny, robbery, carjacking, vandalism, vehicle theft, or a crime as defined by subdivision (b) of Section 13951, unless the disclosure would endanger either of the following:
  - (1) The safety of a witness or other person involved in the investigation.
  - (2) The successful completion of the investigation or a related investigation.

The Department is able to provide you with a synopsis if you wish.

Good afternoon,

The San Jose Police Department has a responsive record referred to as a CHP 180 form that is used to document the vehicle impound and release. The California Courts have held that the CHP 180 form, including the personally identifiable information contained therein, are exempt from disclosure pursuant to County of Los Angeles v. Sup. Ct., (2015) 242 Cal.App.4th 475.

Pursuant to California Government Code Section 7923.605(a), disclosure of records of complaints to, or investigations conducted by, any state or local police agency is not required except to certain interested parties. Said interested parties include victims of a crime, or an authorized representative thereof, an insurance carrier against which a claim has been or might be made, and any person suffering bodily injury or property damage or loss. The event was reviewed, and the circumstances of the event do not indicate that a crime had occurred. Therefore, the requested records are exempt from disclosure.

The Department of Transportation (DOT) is the owner of the remaining tow records you are seeking. As previously stated, the request was coordinated with the DOT. The City Manager's Office confirmed that the DOT responded to your request separately.

This letter is in response to your Public Records Act (PRA) appeal to the Open Government Manager and City Clerk sent on May 31, 2024, pertaining to the City's response to your November 16, 2023 PRA request. I have reviewed your request and below are my findings:

- According to the San José Police Department (SJPD), the City received your request and entered it into our online GovQA platform on or around November 16, 2023 (tracking number P001078-111623).
- SJPD provided a response to your request on May 16, 2024 requesting clarification on whether or not you were looking for a copy of a tow permit, or other records. This communication is attached as **Exhibit A**. On May 17, 2024 you replied: "April, I want all the items stated in my request included in your reply, including the tow permits. Lmk when u are gonna provide them since its been 6 months since i made the request???" These correspondences are attached as **Exhibit B**.
- On May 17, 2024 SJPD provided a response to your PRA request. First, SJPD reiterated the original request: "This is a public records request to supply me with any and all vehicle postings, notes, files, reports, testimony, emails, texts, voicemails, and photographs, and dash cams and or body cam videos and any other information or legal justification pertaining to this illegal tow of my vehicle(s) by SJPD Badge #4867 and Case # 23-317-0492 and permit # 23-931. Also provide me with the name of SJPD Badge # 4867 and all pages of Case # 23-317-0492 and all pages of permit # 23-931." Second, SJPD notified you that the records are considered investigatory records and are exempt from public disclosure. This letter is attached as **Exhibit** C.
- On May 20, 2024 you requested a copy of the synopsis of the tow. The City responded same day, notifying you that they have submitted the request for a synopsis from their Operations Support Services Division and will upload the synopsis upon receipt, in

- addition to notifying you of its availability. On May 25, 2024 the synopsis was provided to you and is attached as **Exhibit D**.
- On May 28, 2024, you stated you were experiencing issues with access the documents. I personally responded on May 30, 2024 confirming that I have sent the requested records directly to <u>tosworld44@gmail.com</u>. These correspondences are attached as **Exhibit E**.
- On June 3, 2024, SJPD acknowledged possession of a California Highway Patrol (CHP) 180 form as responsive to your PRA request. They advised the Courts held this record is exempt from disclosure under the PRA pursuant to *County of Los Angeles v. Sup. Ct.* (2015) 242 Cal.App.4th 475. Additionally, staff further clarified that the record was exempt as an investigative record under California Government Code § 7923.600, except perhaps to an entitled party—namely, a victim of an incident or crime as defined under Government Code § 7923.605. Lastly, staff confirmed that the Department of Transportation provided you with related tow records under the separate PRA request you submitted directly to them. The entirety of this correspondence is attached as **Exhibit F.**
- On June 12, 2024, you appealed the June 3, 2024 response through the GovQA platform, in addition to emailing the Clerk's Office directly. On June 13, 2024, staff confirmed receipt of the appeal. These correspondences are attached as **Exhibit G.**

I have met with staff for clarification and the City of San José stands by SJPD's decision to withhold the requested records, notwithstanding the synopsis that SJPD provided and certain requested information relating to the involved officer.

First, under the PRA, Cal. Govt. Code § 7923.600 does not require the disclosure of records of investigations conducted by any local police agency, or investigatory files compiled by a local police agency. Notwithstanding this statutory exemption, certain types of information relating to specifically listed crimes, housed in these otherwise exempt records, must be disclosed to certain recipients as listed in Cal. Govt. Code § 7923.605, except where disclosure would endanger the completion of an investigation. These specific crimes include arson, burglary, fire, explosion, larceny, robbery, carjacking, vandalism, vehicle theft, or a crime as defined by § 13951(b) (Cal. Govt. Code § 7923.605(a)).

According to the Police Department, many of the records you seek are investigatory files, which may be withheld under § 7923.600. Disclosure of information contained in these exempt records need only be disclosed to "victims" of a "crime" or "incident" as defined by statute, and listed above, under § 7923.605 subdivision (a). Staff advised the incident referenced in your request was logged as a parking violation only, and no qualifying "crime" or "incident" had occurred.

As such, City may withhold these requested records, pursuant to Cal. Govt. Code §§ 7923.600 and 7923.605, as exempt investigatory files, as determined by April Benoit from the SJPD Research and Development Unit on May 17, 2024. As indicated in **Exhibit D**, SJPD provided

you with the synopsis of the incident. Please let me know if those attachments were viewable, or if you require assistance receiving those.

Second, the PRA permits nondisclosure of records which remain protected pursuant to federal or state law under Govt. Code § 7927.705. California law states that information on the CHP 180 forms may be withheld under the PRA pursuant to Govt. Code § 7927.705, because they contain sensitive personally identifiable information (*County of Los Angeles v. Superior Court* (2015) 242 Cal.App.4th 275, 483-85). Thus, although SJPD identified a responsive tow record—the CHP 180 form—for your request, it may be withheld pursuant to state law so as to protect the confidential information contained within. This was discussed in SJPD's June 3, 2024 correspondence to you as shown in **Exhibit F**. However, staff should have raised the PRA exemption found in Govt. Code § 7927.705.

This letter concludes the City's response to your appeal and your request is now completed.

Any person who believes that he/she/it has been inappropriately denied access to City of San José public records, may appeal to the City Council Rules and Open Government Committee, or at any time, the requester may file a complaint with the Santa Clara County Superior Court as set forth in the Public Records Act.
