

I currently serve on the Lived Experience Advisory Board (LEAB) and I have been an executive board member as well on that Board. As an executive board member I was the community relations coordinator and I was responsible of creating and nurturing relationships with different entities within the community of Santa Clara County for LEAB members to participate in. I have also participated in general and numerous advisory committees including West Valley Community Services advisory committee of people with lived experience of homelessness. Once a month we participate in a "action hour" where we hands on make phone calls or reach out to members of this city as an attempt to get their backing over a topic or issue we want to bring awareness to within the unhoused community.

I have attended and completed training provided by Toastmasters so as to improve and strengthen my public speaking in any environment, as well as effectively and efficiently delivering a quality message. Through CEN Center for excellence in nonprofits I have taken many of their trainings and workshops in conjunction with currently being a part of the cohort for building representative boards BRB that I was chosen to participate in. I have taken the "Fundraising Basics" training where we explored the basic fundraising process, reviewed the board's role in fundraising, gained the framework to build a comprehensive fundraising plan, and learned how to develop and communicate a case for support. I also have completed the "Making the Ask" fundraising training where we explored and practiced strategies and techniques to set proper expectations (clarifying roles), how to expand my team's ability to raise money for our organization, and maximize our impact. I have taken a training and am knowledgeable of "Intentional Branding: You and Your Organization" which applies to organizations and individuals alike. In the workshop, we were encouraged to define our personal professional brands and do so in service and support of our organizations' brands as well. I have taken a training on "Compassionate Leadership" where we unpacked the nonprofit sector's historical leadership models that fall short of serving the creation of an IDEAL workspace. We explored what it means to lead with wisdom and compassion and to strike a balance between the two. I have taken a training on "Leading Others Through Change" which was designed to provide the tools and techniques to lead my organization through times of change and crisis more effectively. As a result I left with a clearer understanding of what happens to people when an organizational change initiative (both expected and unexpected) occurs, and felt more prepared to address the myriad challenges that come my way. I've attending a training on "Preventing Burnout: Self-Care in a Selfless Sector" which provides the space and tools to help me lean in without burning out. My journey and becoming homeless started with having a car accident in Yosemite while working at San Jose Family Camp and sustaining a brain injury. This occurred in June of 2014, after which I was rehabilitating for the next three months. During this time I was staying with close friends on their couch and they helped me as I was rehabilitating. I began to experience heavy depression because of the cognitive issues and behavioral issues that I had after obtaining the brain injury. I didn't want to be a burden and so I began to live out of an old SUV that was given to me by one of the friends I was staying with. I was then given a car by my mother and used that to drive around during the day and I used the SUV to sleep in at night. This went on until around August of 2015 when both vehicles were eventually towed for different reasons. When this occurred I was then physically on foot and only was allowed to grab the handful of items from my vehicle before it was taken into the tow yard. My journey began first over off of Monterey Road and Tully/Curtner area. I experienced here the first feeling of loss when someone took all of my more expensive possessions. I assumed you knew what it felt like to literally only have the clothes on your back and have to start all over again. This occurred numerous times over the years that I was unhoused. Everytime it became less and less detrimental to my life and I became accustomed to simply starting over from nothing. I soon realized and learned that being a woman on the streets was extremely dangerous and my safety was always in jeopardy. In order to be safe as a woman living on the streets you either became pimped out, a "mama" of a camp, which meant you could never leave it and looked over it, or you had to become the best at everything of the lifestyle. This meant everything from stealing to violence, to having the best drugs and array of criminal activity. Never in my life as a child did I ever for once believe that when I got older I would become homeless. However, due to a series of events this became the reality in the summer of 2014. In 2015 after losing both my vehicles in the safety that it provided I relocated to the downtown San Jose area. Everyone on the southside of San Jose told me to stay away from downtown because it was the most dangerous place to be home with that. This is the reason I went there. I knew that I had to become somebody I didn't recognize anymore if I was going to survive being homeless. I only remember how terrified I was and I truly believed that I was going to die while living on the streets. But when you are pushed to the limit every single day and you are forced to live in the state of "survival mode" 24/7, you learn what you're really made of; who you are at the core of your essence. I never lost my compassion and kindness in spite of the obstacles and tribulations I was faced with. I was homeless from the summer of 2014 until I got housing in the summer of 2017. During this time I was assaulted physically numerous times, I was raped numerous times oh, I was robbed numerous times and I was incarcerated Elmwood numerous times for a plethora of different charges. I was blessed with receiving a Housing Voucher in the summer of 2017 and have since sustained my housing and have remained housed in San Jose. I am passionate about working with the unhoused immunity as well as initiating discussion around policy reform to decriminalize homelessness and improve



I have been homeless since 2015. It really began with an eviction in 2013, which led me to stay in hotels with my son for about 3 months before couch surfing with friends for half a year and finally finding a new apartment. My complex was sold and the new owner wanted to move into my unit (since it was the best kept and cleanest). I did not want to move out of the school district my autistic son was in, and commuted him from various places in the county for a summer and from South San Jose to Cupertino during the school year. My long term stint with homelessness began in 2015 after I was hospitalized with mental health issues and lost my job because of returning back to work too soon, and was evicted again. I lost custody of my son during that period and he has not lived with me full time since, even though he lived with me full time before everything fell apart. I am educated, and also neuro-divergent a fact people weren't as understanding of in the past. Mental health and homelessness is very important to me because of my past experiences. I was forced out of the corporate world, and lost my livelihood and my family, but I always kept my son as a priority and always worked to provide for him. I have lived on the streets, in my car (when I would have one), in my storage unit, in hotels and in shelters. There's a lot more that has occurred during this time, but this is the gist of it.


