1. Employee Travel Expenses Audit Report.

City Auditor, Joe Rois; Program Performance Auditor II, Auditor's Office, Ebele Obi; Program Performance Auditor I, Auditor's Office, Adrian Perez; and Finance Director, Rick Bruneau offered the presentation and responded to questions.

<u>Public Comments</u>: (Zoom speakers) Paul Soto, Kathryn Hedges (SURJ), and Blair Beekman provided public testimony regarding the item.

Action: Upon motion by Councilmember Arjun Batra, seconded by Councilmember Omar Torres and carried unanimously, the Committee accepted the report on the audit of employee travel expenses and cross-referenced the audit report to the full Council for approval at the June 6, 2023 City Council Meeting. 2. Recruitment, Hiring, and Retention Strategies Status Report.

Director, Employee Relations, Human Resources Department, Jennifer Schembri; Assistant Director, Human Resources Department, Kelli Parmley; and Assistant to the City Manager, Demetria Machado offered the presentation and responded to questions.

Councilmember Sergio Jimenez suggested that employment advertisements also be displayed on the San José Mineta International Airport screens the City currently has an agreement with and requested current information regarding City referral incentives being offered to employees.

<u>Motion</u>: Councilmember Omar Torres moved acceptance of the status report on recruitment, hiring and retention strategies. The motion was seconded by Councilmember Bien Doan.

<u>Friendly Amendment</u>: Councilmember Arjun Batra requested that all future reports update the table on pg. 3 to reflect the number of people who have retired that month and the number of people who've left for other reasons as part of the motion. Lieutenant, San José Police Department, Paul Hamblin and Assistant to the City Manager, Office of the City Manager, Peter Ortiz Hamilton offered the presentation and responded to questions.

<u>Public Comments</u>: (Zoom speakers) Blair Beekman, Kathryn Hedges (SURJ), Paul Soto, Poncho Guevara, and Sandra Asher offered public comment regarding the item.

Councilmember Sergio Jimenez requested that a "Referral Date" column be added to the existing "Attachment A: Recommendations List" for the item but not as part of the motion. Staff stated the request was feasible.

<u>Action</u>: Upon motion by Councilmember Omar Torres, seconded by Vice Mayor Rosemary Kamei and carried unanimously, the Committee accepted the status report on the recommendations for reform and operational improvement being tracked by the Police Department and *cross-referenced the item to the full Council at an August City Council Meeting (specific date not specified on the record).* (5-0.)
