SUBJECT: RETROACTIVE APPROVAL OF THE CALTRANS COMMUNITY MEETING SPONSORED BY COUNCIL DISTRICT 3 AS A CITY COUNCIL SPONSORED SPECIAL EVENT TO EXPEND CITY FUNDS AND ACCEPT DONATIONS OF MATERIALS AND SERVICES FOR THE EVENT

RECOMMENDATION

- 1. Retroactively approve the Caltrans Community Meeting scheduled on August 1,2018 as a City Council sponsored Special Event and approve the expenditure of funds.
- 2. Approve and accept donations from various individuals, businesses, or community groups to support the event.
- 3. Place the item on the August 21, 2018 Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Caltrans Community Meeting was held on August 1, 2018 at the City Hall Rotunda and sponsored by Councilmember Peralez and Councilmember Jimenez. This special event will provide residents the opportunity to learn Caltrans services and ask questions relating to litter, graffiti, and homeless encampments. The event is free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Peralez will report any cash or in-kind donations received for the
