## **RECOMMENDATION**

Approve an ordinance amending Sections 17.85.120 and 17.85.200 of Chapter 17.85 of Title 17 of the San José Municipal Code to update the responsible agency for the City of San José Energy and Water Building Performance Ordinance from the Environmental Services Department to the Energy Department, as established under Section 2.04.4600 of the San José Municipal Code.

## **SUMMARY AND OUTCOME**

This action will update Sections 17.85.120 and 17.85.200 of Chapter 17.85 of Title 17 of the San José Municipal Code to reflect the organizational transition of the San José Energy and Water Building Performance Ordinance (BPO), along with associated staff and programs, from the Environmental Services Department to the Energy Department, effective July 1, 2025. This update ensures accuracy and alignment with the City of San José's departmental structure.

### **BACKGROUND**

The BPO, adopted by City Council in December 2018, mandates that "covered buildings" (commercial and multi-family buildings 20,000 square feet or larger) annually report energy and water usage through the Environmental Protection Agency's Energy Star Portfolio Manager®. Buildings must also meet specific performance metrics every five years or implement specific improvements if they fall short. Implementation of the BPO has been handled by Environmental Services Department staff.

### <u>ANALYSIS</u>

Effective July 1, 2025, staff, oversight, and implementation responsibilities of the BPO and Climate Smart San José programs transitioned from the Environmental Services Department to the Energy Department. The current San José Municipal Code Sections 17.85.120 and 17.85.200 list the Environmental Services Department as the responsible City of San José department for the BPO. This amendment is necessary to update the referenced department to the Energy Department as the enforcing City of San José department. The proposed update will align with the City of San José's departmental change.

## **Climate Smart San José Analysis**

The recommendation in this memorandum aligns with Climate Smart San José strategies by allowing the BPO to continue facilitating the efficient use of energy and water at covered buildings. This action aligns with the Climate Smart goals by reducing energy and water consumption, increasing the demand for renewable energy, and improving the energy and water efficiency of commercial buildings.
