On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The National Women's Soccer League Championship Welcome Reception will be held at the Janet Gray Hayes Rotunda on Thursday, November 20, 2025. The Welcome Reception will welcome the 2025 National Women's Soccer League (NWSL) Championship to San José as the Championship match is taking place on Saturday, November 22 at Pay Pal Park in San José, one of the premier soccer venues in North America. Members of the National Women's Soccer League, the San Jose Sports Authority, and elected officials will be invited. The goal of the Welcome Reception is to commemorate the special sporting event and increase visibility for the City of San José. On September 9, 2025, the City Council adopted Resolution No. RES2025-316 authorizing "Free Use" for the Welcome Reception. Lighting the City Hall Tower from November 20-22, 2025 will be held in conjunction with the Welcome Reception and the Championship match.

The World AIDS Day Flag Raising will be held on December 2, 2025 and the Tower and Rotunda Lighting will be held on December 1-December 4, 2025 at the City Hall Plaza and sponsored by Vice Mayor Pam Foley. The Worlds AIDS Day Quilt Display in the Rotunda will be on December 1 and December 2, 2025. These special events bring together community members to unite in the fight against HIV, show their support for people living with HIV, and to commemorate people who have died due to HIV. The events are free and open to the public.

The Music in the Valley Festival will be held on May 2, 2026 at Cambrian Park Plaza and sponsored by Vice Mayor Pam Foley. This event showcases the musical talents of middle and high school students across District 9 and featuring local professional bands, offering all-day live music and family-friendly activities such as a rock climbing wall, bounce houses, community resource booths, and arts and crafts. The event will also include local artisan vendors, new for 2026. This event fosters community engagement, supports our local economy, and provides a platform for music to shine in our corner of San José. It brings together families, businesses, and organizations in a celebration of creativity and culture.

ANALYSIS

Lighting City Hall Tower in Decibel Cyan, Mission Magenta & Twilight Purple will further commemorate the 2025 National Women's Soccer League Championship to San José and increase visibility for the City of San José. City Council Policy 7-14, City Hall Event Lighting Policy, Sections B.1 and C.1 allows Tower lighting in conjunction with proclamations for official actions or ceremonial items as approved by City Council.

The display of the World AIDS Day Flag is permitted under Council Policy 2- 1, Section C.3 - Flags Displayed in Conjunction with Official Ceremonial Items: "Other flags may be displayed in conjunction with official actions, ceremonial items, or proclamations of the City Council." Lighting the Tower and Rotunda in red is a symbol of awareness and support for people living with HIV. City Council Policy 7-14, City Hall Event Lighting Policy, Sections B.1 and C.1 allows Rotunda and Tower lighting in conjunction with proclamations for official actions or ceremonial items as approved by City Council.
