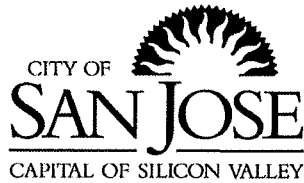

The Dumpster Day was held on January 27, 2018 at Ryan Elementary School. This special event was sponsored by Vice Mayor Carrasco. This special event was held to beautify the Ryan neighborhood. The event was free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Vice Mayor Carrasco will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). 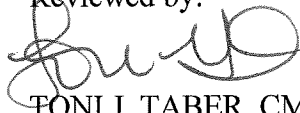
