City Manager Jennifer Maguire shared that Governor Newsom signed AB 645 into law, allowing six California cities including the City of San José to pilot automated speed enforcement, the primary factor behind traffic accidents. This legislation, a crucial component of the City's advocacy strategy and was made possible through collaborative efforts across City departments and received significant backing from those who provided letters of support.
