As noted in the council memo, this practice hurts tenants of corporate real estate while also pushing up rents for everyone else.



We would like to submit this letter before the committee to express our support for the memorandum authored by Councilmembers Ortiz, Cohen, and Torres. This memorandum requests the development of an ordinance to prohibit the use of Algorithmic Devices for Residential Dwelling Units. The impact of this practice on renters, who are already struggling to keep up with the current cost of living, cannot be overstated. There is precedent based on actions taken in other jurisdictions towards combating this practice, which has been identified as a form of "price fixing" focused on increasing rents.

The corporations using this technology are some of the largest corporate property owners in the Country. As corporate real estate continues to grow, we see firsthand what tools, such as this software, are being used to further corporate interests amid a housing and affordability crisis.

With an Department of Justice Antitrust lawsuit on the use of Algorithmic Devices and an ordinance in place in San Francisco, there are examples of what we as a City can do to prevent exacerbating existing housing impacts on renters in corporately owned properties. We urge the committee to move this item forward and make a strong commitment to our residents, not corporate real estate. On behalf of the San Jose Chamber of Commerce, I would like to express our opposition to item C.2: Ordinance Amendment for Sale or Use of Algorithmic Devices for Residential Dwelling Units. The Chamber opposes this ordinance for the reasons outlined below.

- Inconsistent governance: Companies and technologies regulated at the federal and state
 levels are already subject to rigorous oversight. Federal and state regulations are designed
 to ensure safety, privacy, and operational standards. Adding a local ban undermines the
 comprehensive regulatory framework that's already in place, leading to inconsistent
 governance, legal confusion, and diversion of resources.
- Stifles Economic Growth: A local ordinance will stymy investment from AI companies in San Jose. Innovation thrives when businesses and technologies are allowed to operate freely within a consistent regulatory environment. A City ban will stifle growth, limit access to emerging technologies, and reduce the city's competitiveness. This can also discourage new businesses from investing in the city, potentially leading to economic stagnation and setting a negative precedent for bringing a new business to San Jose.
- City Staff Burden: Federal and state agencies have dedicated experts, research teams, and
 infrastructure in place to monitor compliance, enforce regulations, and adapt to emerging
 technologies. City government and staff do not, nor should they, have the technical
 expertise or capacity to focus on the complexities of modern technologies. Attempting to
 regulate at the local level without this expertise could lead to poorly informed decisions,
 inefficiencies, and unintended negative consequences for businesses and residents alike.

Let the Justice Department complete its process over the use of the algorithm used by RealPage. For the reasons outlined above, the Chamber respectfully requests you vote no on this item.
