RECOMMENDATION

- a) Report on bids and award a contract for the construction of 10489 2025-2027 LS Resurfacing (Multi-Term) Project, to the lowest responsive, responsible bidder, MCK Services, Inc., in the amount of \$14,522,607.
- b) Approve a 10% contingency in the amount of \$1,452,260.
- c) Adopt a resolution authorizing the Director of Transportation to:
 - 1) Exercise up to two one-term options (2026 and 2027) for a total amount not to exceed \$15,000,000 for each option term period, contingent on the appropriation of funds; and
 - 2) Establish a construction contingency for any option year of up to 10% of the contract amount, not to exceed \$1,500,000 for each option term, contingent on the appropriation of funds.

SUMMARY AND OUTCOME

Award of the contract to MCK Services, Inc. enables the construction of the 10489 – 2025-2027 LS Resurfacing (Multi-Term) Project (Project), which will provide needed resurfacing of approximately 28 miles of the Local and Neighborhood Streets Network during the initial term in 2025. It is also estimated that an additional 28 miles could be resurfaced with each subsequent one-term option period if exercised. Approval of the 10% contingency will provide funding for any unanticipated work necessary for the proper completion or construction of each project.

BACKGROUND

The Department of Transportation (DOT) will maintain approximately 228 miles of roadway during the 2025 construction season, including 53 miles on the Major Street Network and 175 miles on the Local and Neighborhood Streets Network. As part of this effort, the Local and Neighborhood Streets Network plans to resurface 109 miles of

streets in poor to failed condition and seal 66 miles to extend pavement life and improve

overall roadway conditions.

Pavement maintenance is typically performed in two separate phases: preparation and a final surface application. The preparation phase consists of the installation and upgrade of Americans with Disabilities Act-compliant (ADA) curb ramps. The ADA work is conducted in advance using minor contracts to provide more job opportunities for local and small businesses. The final surface application phase is known as resurfacing, which consists of removing several inches of damaged or degraded roadway and installing a new layer of asphalt, followed by the installation of new striping and markings. To complete 109 miles of resurfacing work in one construction season, all 2025 resurfacing work will be divided into four separate projects and implemented concurrently.

The City's Local and Neighborhood Streets Network is organized into 135 geographically contiguous Pavement Maintenance Zones. The Pavement Maintenance Zones were established several decades ago to support efficient planning and delivery of paving projects, maximize the amount of paving work completed at one time within a neighborhood area, and provide geographic spread of pavement maintenance across the city.

DOT utilizes a pavement management system software called StreetSaver (owned by Metropolitan Transportation Commission) to collect and store roadway condition data. This data is then used to generate a candidate list of streets to be considered for the annual pavement maintenance program. The candidate list is thoroughly analyzed by staff using the following criteria to create the final list of streets.

- Funding availability and funding use restrictions;
- Streets on the Local and Neighborhood Streets Network;
- Streets not affected by current or future street related projects;
- Maintenance history and prescribed treatment schedules;
- Streets associated with planned safety, bikeway, or other "complete streets" projects;
- Community and City Council Office feedback regarding roadway conditions and priority street segments;
- Relative location of street segments to create multiple, continuous segments, consistency within neighborhoods, and project efficiency; and
- Multi-year geographic spread across the city and street network.

In 2021, DOT added equity as a criterion for zone selection. DOT staff cross-referenced the selected zones with census tracts designated by the Metropolitan Transportation Commission as "Equity Priority Communities" (EPC), formerly known as "Communities of Concern," to better track equity in service delivery. Results confirmed that 256 out of 266 miles (roughly 96%) of local and neighborhood streets designated in EPC areas will be maintained by the end of the current three-year plan (2028). DOT anticipates completing pavement maintenance for nearly 91% of the local street network in this same timeframe.

DOT has maintained a total of 198 EPC miles since 2019 and will maintain an additional 30 EPC miles in 2025, which is about 17% of the 175 miles of Local and Neighborhood Streets Network selected for maintenance in 2025. This project includes 1.5 of the 30 EPC miles.

The attachment to this memorandum contains the list of streets to be resurfaced as part of this Project (**Attachment**). The list may change if unforeseen circumstances arise or new information regarding other projects becomes available.

Construction is scheduled to begin in May 2025, with substantial completion by December 2025.

ANALYSIS

Bids were opened on January 23, 2025, with the following results:

The lowest bid submitted by MCK Services, Inc. is 9% below the Engineer's Estimate. The estimate is based on bids received from similar past projects and most current

estimated construction prices. This bid is considered acceptable for the work involved in the Project.

MCK Services, Inc. has completed multiple multi-term projects since the City introduced this contracting approach in 2020. Notably, the company has completed two of the three years of the 2023–2025 LS Resurfacing (Multi-Term) Project and is currently working on the final term, scheduled for completion in 2025. The scope and scale of the Project are comparable to past resurfacing efforts, including:

- 2020–2022 LS Resurfacing (Multi-Term) Project: 20 miles in 2020, 25 miles in 2021, and 24 miles in 2022;
- 2022–2024 LS Resurfacing (Multi-Term) Project: 26 miles in 2022, 25 miles in 2023, and 30 miles in 2024; and
- 2023–2025 LS Resurfacing (Multi-Term) Project: 30 miles in 2023, 27 miles in 2024, and a projected 30 miles by May 2025.

The contract will have an initial term starting upon City Council approval and ending on December 31, 2025, with two additional one-term extension options. Unit prices in the Schedule of Quantities for the initial term will remain applicable for each option year, subject to price adjustments based on the California Statewide Crude Oil Price Index and the California Construction Cost Index. The scope of work during the extension years will remain consistent, covering different locations with approximately the same mileage. The Director of Transportation will have the discretion to extend the contract, contingent on funding availability and appropriation.

To streamline operations and ensure cost efficiency, DOT recommends that the City Council adopt a resolution authorizing the Director of Transportation to execute the two one-term extension options as needed. This approach secures favorable pricing in future years and allows paving operations to begin earlier by reducing procurement-related delays. This contract procurement method was first piloted in 2020 and has proven successful, enabling the efficient resurfacing of 69 miles of local streets over three years.

Contingency

San José Municipal Code Section 27.04.050 provides for a standard contingency of 10% on all public works contracts except those involving the renovation of a building or buildings. The standard contingency is appropriate for this project.

Wage Theft Prevention Policy Check

The Office of Equality Assurance reviewed bidders for compliance with the City's Wage Theft Prevention Policy on January 23, 2025 and again on February 12, 2025. No wage theft issues were identified.

Project Labor Agreement Applicability

The City's Project Labor Agreement is applicable to this project because the Engineer's Estimate is over \$1.21 million.

Local and Small Business Analysis

The recommended contractor is not a local or a small business enterprise. No local or small business enterprises were listed as subcontractors.

EVALUATION AND FOLLOW-UP

DOT provides an ongoing evaluation of the City's pavement conditions and provides periodic reports on this topic to the Transportation and Environmental Committee. In addition to the project discussed in this memorandum, three additional major street projects and four additional local and neighborhood street pavement maintenance projects are scheduled for City Council action this spring.

COST SUMMARY/IMPLICATIONS

These projects support the Transportation and Aviation Services City Service Area goal to Preserve and Improve Transportation Assets and Facilities. By performing pavement maintenance, the extension of the useful life of the project streets will defer more costly reconstruction. The source of funding for these projects is through the 489 – Pavement Maintenance Measure T Bond. These projects will have a net zero impact to the General Fund as the standard in-house operating and maintenance costs are already included in DOT's annual budget.
