**Subject:** Regarding my Response to Tony Andary's Last Minute Request For a Deferral

Dear Shaunn, and Peter,

As per my conversation with both of you today, I want to reiterate that **I strongly oppose any further deferrals regarding the Conditional Use Permit CP16-035**. All the reports, and studies, as well as, onsite visits have been concluded, and it is now time for the Mayor and Council to vote on this project.

**There is nothing more to talk about when it comes to the safety and well being of these school children, my neighbors, and I, or the affects of the noise/noxious odors this car wash will have on myself and my neighbors.**

Further, I want to make it clear that I will not now or in the future meet or speak with with anyone related with Andary Enterprises Inc. regarding this project, because prior to filing my Appeal, I met with Sam Andary and his wife Vicky in August, for two hours trying to come to some kind of an agreement, but they refused all of my suggestions, so I was left with no other recourse but to file an Appeal.

Further, Tony Andary and some of his family member's behaviors has been so unprofessional, and abusive towards me, my landlord's family members, Planning Commission Members, those members of the public who have signed our petitions, the Singh's, and in the hallway after last week's Council Meeting, has made me very concerned about being anywhere near him or them. (Please see the Cease and Desist Letter my attorney sent the Andary's, and my Landlord's letter regarding this matter in the packet I submitted to each one of your offices. Thank you.)

**My hope is that this last minute effort on the part of Tony Andary asking for a deferral is DENIED, and that the Mayor and Council proceeds forward with Council Member Rocha's request that the car wash be denied, and that the convenience store be approved, with all the conditions that City staff included in their Supplemental Memorandum that is scheduled to be heard and voted on during tomorrow's Council Meeting.**

**Please let me know if Tony Andary's request for deferral is approved or denied, and what my due process rights are, because I cannot make it to tomorrow's Council Meeting. I have two doctor's appointments that I cannot and will not cancel again.**
