BACKGROUND

This Study Session will address the approved Rules and Open Government Committee directive as recommended in the October 30, 2024 memorandum from Councilmember Ortiz¹ which included the following:

"Direct the City Clerk and City Manager to schedule a City Council Study Session on parks maintenance, capital funding, and preliminary work plan for a 2026 Parks Funding Ballot Measure in January or February of 2025."

Given the large scope of work to prepare for this Study Session, the Parks, Recreation and Neighborhood Services Department was granted a deferral to April 15, 2025.

The City of San José officially established its Parks and Recreation Department in 1942. Now called the Parks, Recreation, and Neighborhood Services (PRNS) Department, the Department's Core Services include:

- Community Facilities Development (Create uniquely San José places that foster relationships with people and nature and offer a civic presence),
- Community Services (Empower and support residents, schools, and local organizations to make the City more livable, safe, and clean),
- Parks Maintenance and Operations (Ensure the proper maintenance and operation of City parks, trails, and open spaces that provide opportunities for residents to connect to nature and lead active, healthy lifestyles,
- Recreation Services (Through recreation, promote play and health, strengthen communities, and enrich lives), and
- Strategic Support (Budget and Financial Management Services, Contracting Services, Employee Services, Marketing and Public Information, and Emergency Response and Recovery).

The PRNS Department has evolved to address diverse community needs through various initiatives, but at its core, the Department is focused on creating healthy communities that inspire belonging. Through the Parks Maintenance and Operations Core Service, maintaining safe and thriving parks is critical to this vision.

For years, the PRNS Department has been exploring opportunities to create more permanent funding for San José parks, including a tax or bond measure. On August 6, 2024, the City Council directed staff to defer consideration of a measure from the 2024 election to the 2026 ballot so staff can educate and engage the community on the topic.

On October 30, 2024, the Rules and Open Government Committee approved a recommendation from Councilmember Ortiz to hold a City Council Study Session on
