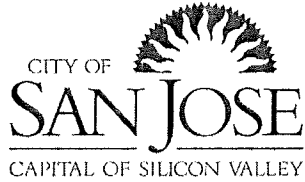

## RECOMMENDATION

## BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The 14<sup>th</sup> Annual Santos Family Car Show will be held on August 31, 2019 at 5202 N. First Street, Alviso, CA 95002 from 8:00 a.m. – 3:00 p.m. and is sponsored by Councilmember Lan Diep. This special event highlights an extensive array of vintage and classic cars from around the Bay Area. Many car enthusiasts arrive before 5:00 a.m. for prime parking along North First Street, Alviso's main thoroughfare, as neighboring streets and parking lots tend to fill up by 7:30 a.m. with classic cars, trucks, and hot rods. The atmosphere is festive and vibrant, with classic hits from the 1950s setting the tone and vendors scattered throughout, selling auto parts, arts & crafts, food, jewelry, and more. It has been sponsored and organized by the Santos family since its inception, and is free and open to the public. The District 4 sponsorship of this community event is intended to attract visitors to Alviso and for residents to discover the Alviso Marina along with area restaurants and amenities.
