*Section 6.16 - The Committee may elect to establish ad hoc committees for short-term needs. The scope and purpose of an hoc committee must be specific and narrow, and must be defined when established. Ad hoc committees may not go beyond the scope of the Committee's duties and authority, and may not be formed to bypass City law or policy. Establishment of ad hoc committees must be agendaized and approved by the Committee in a regular or special meeting by majority vote. Ad hoc committee membership must be determined upon establishment of such committee and shall not comprise a quorum of the full Committee. Ad hoc committees shall expire six months after they are established. ~~A quorum of ad hoc members must be present in order to hold an ad hoc meeting.~~ Committee members are not required to serve on ad hoc committees. ~~Ad hoc committee meetings shall be noticed and called in accordance with sections 6.3 and 6.4 of these bylaws.~~
