AN ORDINANCE OF THE CITY OF SAN JOSE REZONING CERTAIN REAL PROPERTY OF APPROXIMATELY 21 GROSS ACRES SITUATED ON THE NORTH SIDE OF SAMARITAN DRIVE AND THE WEST SIDE OF SAMARITAN PLACE, APPROXIMATELY 275 FEET EAST OF KINGHURST DRIVE (APNS 421-36-009 AND 421-36-011), FROM THE A(PD) PLANNED DEVELOPMENT ZONING DISTRICT TO THE CG(PD) PLANNED DEVELOPMENT ZONING DISTRICT

WHEREAS, all rezoning proceedings required under the provisions of Chapter 20.120 of Title 20 of the San José Municipal Code have been duly had and taken with respect to the real property hereinafter described; and

WHEREAS, the approximately 21-gross-acre site encompassed by the proposed rezoning was the subject of that certain Final Environmental Impact Report ("FEIR") for the Good Samaritan Hospital Project (File No. ER23-041) in conformance with the California Environmental Quality Act of 1970 ("CEQA"), as amended, which evaluated the impact of the phased demolition of a portion of the hospital and the child care center, for the construction of two new hospital wings with a total floor area of approximately 750,000 square feet, an approximately 200,000-square-foot medical office building, and an approximately 24,000 square foot central utility plant, on an approximately 21-gross-acre site, which FEIR was certified and for which findings were adopted by the City Council on 2024; and

WHEREAS, the City Council of the City of San José is the decision-making body for the proposed subject rezoning to the CG(PD) Planned Development Zoning District; and

WHEREAS, this Council of the City of San José has considered and approves the

WHEREAS, the proposed rezoning is consistent with the designation of the site in the

applicable General Plan.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SAN

JOSE:

SECTION 1. The recitals above are incorporated herein.

SECTION 2. All that real property hereinafter described in this section, hereinafter referred

to as "subject property," is hereby rezoned to the CG(PD) Planned Development Zoning

District. The base district zoning of the subject property shall be the CG Commercial

General Zoning District. The Planned Development Zoning of the subject property shall be

that development plan set for the subject property entitled, "Good Samaritan Hospital

Planned Development Zoning PDC22-132" dated September 13, 2024 ("General

Development Plan").

The subject property referred to in this section is all that real property situated in the County

of Santa Clara, State of California, described in Exhibit "A" and depicted in Exhibit "B"

attached hereto and incorporated herein by this reference.

SECTION 3. The district map of the City is hereby amended accordingly.

SECTION 4. Any land development approval that is the subject of City File No. PDC22-

132 is subject to the operation of Part 2.75 of Chapter 15.12 of Title 15 of the San José

Municipal Code. The applicant for or recipient of such land use approval hereby acknowledges receipt of notice that the issuance of a building permit to implement such land development approval may be suspended, conditioned or denied where the City Manager has determined that such action is necessary to remain within the aggregate operational capacity of the sanitary sewer system available to the City of San José or to meet the discharge standards of the sanitary sewer system imposed by the California Regional Water Quality Control Board for the San Francisco Bay Region.

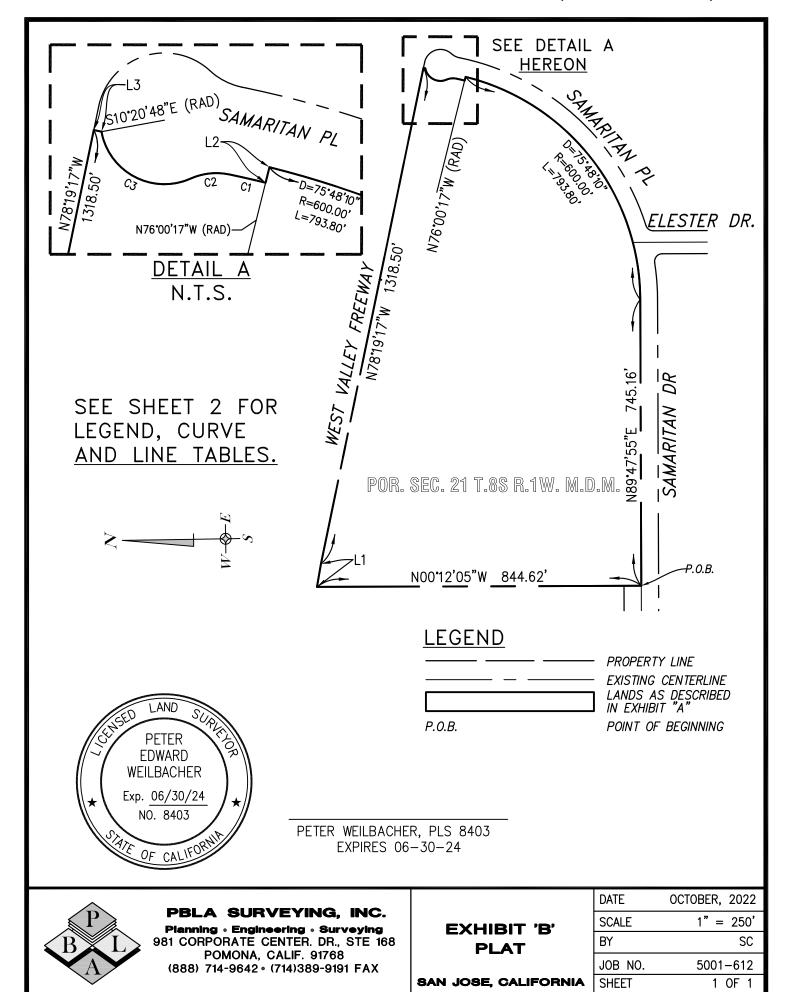

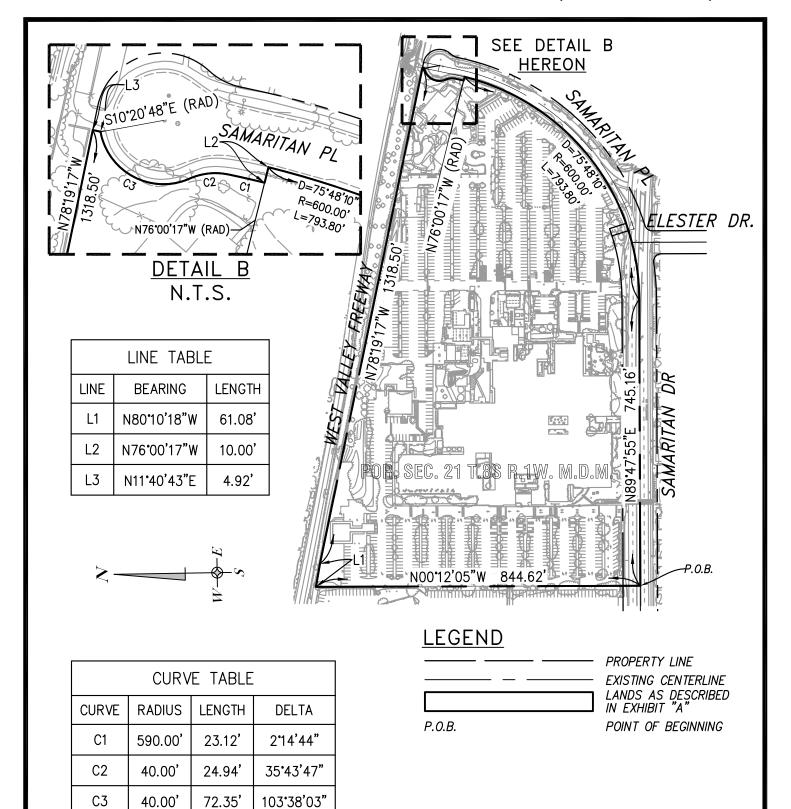
