

RESOLUTION NO.

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE CONFIRMING THE APPROVAL OF THE ANNUAL REPORT AND THE PLACEMENT OF THE CHARGES AS SET FORTH THEREIN ON THE 2026-2027 SANTA CLARA COUNTY SECURED PROPERTY TAX ROLL, WITH SUCH MODIFICATIONS THE CITY COUNCIL MAY MAKE BASED ON PUBLIC HEARING TESTIMONY

WHEREAS, Section 15.12.550 of the San José Municipal Code requires the Director of Finance to file a report each year (“Annual Report”) with the City Clerk, on or before July 5th, or such other date or dates as the Council of the City of San José (“City”) may specify by resolution, regarding Sanitary Sewer Service and Use Charges, and requires the City Clerk to cause notice of filing of the report issued by the Director of Finance regarding the imposition of the Annual Report, and the time and place of the public hearing; and

WHEREAS, Section 15.16.1410 of the San José Municipal Code requires the Director of Finance to file a report each year with the City Clerk, at least fifteen (15) days before the public hearing on the Storm Sewer Service Charge assessments, and requires the City Clerk to cause notice of filing of the report issued by the Director of Finance regarding the imposition of the Annual Report, and the time and place of the public hearing; and

WHEREAS, pursuant to San José Municipal Code Sections 15.12.550 and 15.16.1410, and Resolution No. RES2026-192 of the City Council, the City Clerk set the public hearing on the Annual Report for Fiscal Year 2026-2027 of the Director of Finance on Sanitary Sewer Service and Use Charges and Storm Sewer Service Charges for August 11, 2026, at 1:30 p.m., or as soon thereafter as the matter may be heard; and

WHEREAS, pursuant to the San José Municipal Code Section 15.12.550 and Resolution No. RES2026-192, the City Council approved an extension of the date that the Director of Finance must deliver the Annual Report to the City Clerk by July 15, 2026; and

WHEREAS, the Annual Report was filed with the City Clerk's Office on July 15, 2026, in accordance with the San José Municipal Code and Resolution No. RES2026-192; and

WHEREAS, the notices for the public hearing of August 11, 2026, on the Annual Report were published in accordance with the San José Municipal Code and state law; and

WHEREAS, the City desires to confirm the approval of the Annual Report and the placement of the Sanitary Sewer Service and Use Charges and Storm Sewer Service Charges on the 2026-2027 Santa Clara County Secured Property Tax Roll;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE THAT:

1. Approval of the 2026-2027 Annual Sanitary Sewer Service and Use Charge and Storm Sewer Service Charge Report of the Director of Finance is hereby confirmed.
2. Approval of the placement of the Sanitary Sewer Service and Use Charges and Storm Sewer Service Charges as forth in the Annual Report on the 2026-2027 Santa Clara County Secured Property Tax Roll is hereby confirmed.
