The purchase of event supplies and beverages for the Coffee with the Captain was for the community that wanted to learn more about District Three and the San José Police Department's capacity and public safety items.

The Lowrider event was held on September 1st, 2023 at San José City Hall Plaza and was sponsored by Councilmember Omar Torres. The Lowrider event was the first annual

celebration of the removal and end-to the cruising ban. This special event was an opportunity for community members to interact with the San José Chicano and Hispanic culture.
