First Substantial Amendment to FY 2021-22 Annual Action Plan

- In 2021, the City of San José was awarded \$11,676,334 in HOME Investment Partnerships Program (HOME) American Rescue Plan (HOME-ARP) funds
- The amendment enables the City to spend HOME ARP federal funding in Fiscal Year 2023-24
- The deadline for submitting the Allocation Plan is March 31st

HOME American Rescue Plan (ARP)

Funds must be used to primarily benefit individuals or families who are:

- Homeless
- At-risk of homelessness
- Fleeing, or attempting to flee domestic violence, dating violence, sexual assault, stalking, or human trafficking
- Veterans and families that include a veteran family member that meet one of the preceding criteria

Eligible Activities

- ❑ Production or Preservation of Affordable Housing
- ❑ Tenant-Based Rental Assistance (TBRA)
- ❑ Supportive Services, Homeless Prevention Services, and Housing Counseling
- ❑ Purchase and Development of Non-Congregate Shelter

HOME ARP Consultation Process

- 🏠 **Listening sessions:** :Persons with Lived Experience, and Community and nonprofit agencies serving the qualifying populations
- 🏠 **Webpage:** one-stop center for public interested in information, viewing draft plan, submitting comments
- 🏠 **Survey:** multi-lingual online survey in English, Spanish and Vietnamese open to the public during February

HOME ARP Allocation Proposal

Homelessness Prevention	500 individuals to be served	\$3,000,000
Tenant-Based Rental Assistance (TBRA)	300 individuals to be served	\$4,500,000
Supportive Services for Homeless at Non-congregate Shelter	300 individuals to be served	\$2,424,884
Administration and Planning of the HOME ARP Allocation Plan		\$1,751,450
TOTAL		\$11,676,334

Performance Metrics

Homeless Prevention:

85% remain stably housed one year after receiving services

Tenant-Based Rental Assistance:

83% of individuals will exit to permanent housing

Supportive Services for Homeless as Non-congregate Shelter:

32% of individuals will exit to permanent housing
