BACKGROUND

On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The District 4 Groundbreaking Ceremony for Mercado and Bruzzone Parks was held on Sunday, October 1, 2023 from 11:00am to 12:00pm at Sierra Road and Mercado Way. The purpose of this

event was for San Jose Residents to commemorate the start of construction at Mercado and Bruzzone Parks. This event was free and open to the public.

The Day on The Bay will be held on Saturday, October 14, 2023 from 10:00am to 3:00pm at the Alviso Marina County Park. The purpose of this event is for San Jose Residents to create lasting memories with family and community members while enjoying aquatic activities, performances from local artists, and resource tables. This event is free and open to the public.

The District 4 Pumpkin Giveaway will be held on Wednesday, October 18, 2023 from 5:00pm to 7:00pm at 1376 Piedmont Road. The purpose of this event is to celebrate Halloween with San Jose residents by providing free full-sized pumpkins for individuals to decorate. This event is free and open to the public.

The Cherrywood Elementary School Fall Festival will be held on Friday, October 27, 2023 from 5:00pm to 7:00pm at Cherrywood Elementary School. The purpose of this event is to foster community engagement among families and their community organizations. There will be a Trunk or Treat, Pumpkin Decorating Contest, food trucks, and games. This event is free and open to the public.

The Halloween Spooktacular will be held on Friday, October 27, 2023 from 6:00pm to 8:30pm at the Berryessa Community Center. The purpose of this event is to cultivate community connections among San Jose residents while they enjoy a costume contest, haunted house, pumpkin patch, and crafts. This event is open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember David Cohen will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 4, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
