**SUBJECT:** Report on Bids and Award of Contract for the 10493 – 2025 Local Streets Remove and Replace Project

## **RECOMMENDATION**

- a) Report on bids and award a contract for the construction of 10493 – 2025 Local Streets Remove and Replace Project, to the lowest responsive, responsible bidder, MCK Services, Inc., in the amount of \$3,870,050.
- b) Approve a 10% contingency in the amount of \$387,005.

## **SUMMARY AND OUTCOME**

Award of the contract to MCK Services, Inc. enables the construction of the 10493 – 2025 Local Streets Remove and Replace Project (Project), which will provide needed asphalt concrete pavement repairs along 66 miles of the Local and Neighborhood Streets Network to be sealed in the 2025 construction season. Approval of the 10% contingency provides funding for any unanticipated work necessary for the proper completion or construction of the Project.

## **BACKGROUND**

The Department of Transportation (DOT) will maintain approximately 228 miles of roadway during the 2025 construction season, including 53 miles on the Major Street Network and 175 miles on the Local and Neighborhood Streets Network. As part of this effort, the Local and Neighborhood Streets Network plans to resurface 109 miles of streets in poor to failed condition and seal 66 miles to extend pavement life and improve overall roadway conditions.

Pavement maintenance is typically performed in two separate phases: preparation and a final surface application. The preparation phase consists of the installation or upgrade of Americans with Disabilities Act - compliant curb ramps and the removal and replacement of failed asphalt pavement. The Americans with Disabilities Act work is conducted in advance using minor contracts to provide more job opportunities for local and small businesses. Streets to be sealed will also require the removal and replacement of any structurally failed areas of pavement prior to the final surface application phase. The final surface application phase is known as a sealing application, which provides a thin layer of asphalt emulsion blended with rock approximately 3/8 of an inch in thickness to the pavement.

The City's Local and Neighborhood Streets Network is organized into 135 geographically contiguous Pavement Maintenance Zones. The Pavement Maintenance Zones were established several decades ago to support efficient planning and delivery of paving projects, maximize the amount of paving work completed at one time within a neighborhood area, and provide geographic spread of pavement maintenance across the City.

DOT utilizes a pavement management system to collect and store roadway condition data. This data is then used to generate a candidate list of streets to be considered for the annual pavement maintenance program. The candidate list is thoroughly analyzed by staff using the following criteria to create the final list of streets.

- Funding availability and funding use restrictions;
- Streets on the Local Street Network;
- Streets not affected by current or future street related projects;
- Maintenance history and prescribed treatment schedules;
- Streets associated with planned safety, bikeway, or other “complete streets” projects;
- Community and City Council Office feedback regarding roadway conditions and priority street segments;
- Relative location of street segments to create multiple, continuous segments, consistency within neighborhoods, and project efficiency; and
- Multi-year geographic spread across the City and street network.

In 2021, DOT added equity as a criterion for zone selection. DOT staff cross-referenced the selected zones with census tracts designated by the Metropolitan Transportation Commission as Equity Priority Communities (EPCs), formerly known as Communities of Concern, to better track equity in service delivery. Results confirmed that 256 out of 266 miles (roughly 96%) of local and neighborhood streets designated in EPC areas will be maintained by the end of the current three-year plan (2028). DOT anticipates completing pavement maintenance for nearly 91% of the local street network in this same timeframe.

DOT has maintained a total of 198 EPC miles since 2019 and will be maintaining an additional 30 EPC miles in 2025, which is about 17% of the 175 miles of local and neighborhood streets selected for maintenance in 2025. This project includes 11 EPC miles, which is about 17% of the anticipated 66 sealing miles.

The **Attachment – List of Streets** contains the list of streets to be sealed as part of this Project. The list may change if unforeseen circumstances arise or new information regarding other projects becomes available.

Construction is scheduled to begin in late April 2025 with a substantial completion in August 2025.

## **ANALYSIS**

Bids were opened on February 6, 2025, with the following results:

The lowest bid submitted by MCK Services, Inc. is \$3,870,050 and is 14% below the Engineer's Estimate. The estimate is based on bids received from similar past projects and most current estimated construction prices. The bid is considered acceptable for the work involved in the Project.

One potential reason bids came in lower than the Engineer's Estimate, is due to the timing of when the Project was advertised. This Project advertised earlier in the year compared to the 2024 contract which was advertised later in the calendar year closer to when contractors were into their construction season. This earlier advertisement led to a higher number of bid submissions and more competitive pricing, as many contractors had not yet committed to other projects and still had available capacity.

MCK Services, Inc. has a strong track record, successfully completing multiple pavement projects. Notably, the company has completed two of the three years of the

2023–2025 Local Streets Resurfacing (Multi-Term) Project and is currently working on the final term, scheduled for completion in 2025.

*Contingency*

San José Municipal Code Section 27.04.050 provides for a standard contingency of 10% on all public works contracts except those involving the renovation of building or buildings. The standard contingency is appropriate for this project.

*Wage Theft Prevention Policy Check*

The Office of Equality Assurance reviewed bidders for compliance with the City's Wage Theft Prevention Policy on February 6, 2025, and again on February 12, 2025. No wage theft issues were identified.

*Project Labor Agreement Applicability*

The City's Project Labor Agreement is applicable to this project because the Engineer's Estimate is over \$1.21 million.

*Local and Small Business Analysis*

The recommended contractor is not a local or a small business enterprise. There is one local business listed as a subcontractor. Graham Contractors (San José) will perform crack filling work valued at approximately \$877,500.

**EVALUATION AND FOLLOW-UP**

DOT provides an ongoing evaluation of the City's pavement conditions and provides periodic reports on this topic to the Transportation and Environment Committee. In addition to the project discussed in this memorandum, three additional major street projects and four additional local and neighborhood street pavement maintenance projects are scheduled for City Council action this spring.

**COST SUMMARY/IMPLICATIONS**

These projects support the Transportation and Aviation Services City Service Area's goal to Preserve and Improve Transportation Assets and Facilities. By performing pavement maintenance, the extension of the useful life of the project streets will delay the need for more costly reconstruction. The source of funding for these projects is through the 486 – VTA Measure B 2016 (Complete Streets - use for residential) fund.
