Due to state-mandated increases in retirement contributions, Campbell Union High School District is facing a budget deficit, and has been working very hard to identify sources of on-going, unrestricted revenue to offset this additional cost. As a member of the Campbell Union High School District community, I am urging you to support the District's very creative efforts to convert the district office/maintenance yard into an ongoing revenue stream. This ongoing revenue will benefit our students by not forcing cuts to any existing programs or staff in order to counteract the upcoming budget deficit.

The proposed development of the existing parcel is very compatible with the neighborhood. The two visible ends of the parcel which front on Camden or Union would remain commercial. The hidden center of the thin parcel which borders single family residential on either long side would also become single family residential to match. It would make for a much more pleasant experience for the existing residents and increases the property values of their homes. And the additional numbers of ADU's proposed along with the new single family homes would go a long way to meeting the State's housing mandates during our housing crisis.
