OF THE RESULTS OF THE JUNE 24, 2025 RUNOFF MUNICIPAL ELECTION AND

OATH OF OFFICE

RECOMMENDATION

a. Adopt a resolution declaring and recording a statement of the results of the June 24, 2025 Runoff Municipal Election per Elections Code Sections 10263, 10264, and 15400; and

b. Administer the Oath of office for newly elected District 3 Councilmember Anthony Tordillos.

OUTCOME

The resolution will declare the results of the election, as certified by the Santa Clara County Registrar of Voters, and record a statement of the election of Office of Councilmember—District 3: Anthony Tordillos

BACKGROUND

The City Council adopted Resolution No. 2024-407 on December 3, 2024 calling for a Special Primary Municipal Election to be held on April 8, 2025 and a Run-Off Election, if necessary, on June 24, 2025 to elect one person to fill the unexpired term for District 3. All Municipal Elections were consolidated with the County of Santa Clara and held in accordance with established procedures governing the conduct of elections. Under the Elections Code, the County Registrar of Voters has thirty days to certify the results of an election. The City Clerk's Office received the official certification of results on July 24, 2025

ANALYSIS

Of the 47,189 voters registered for this election, a total of 8,366 ballots were cast for a turnout of 17.73%. The official final results for June 24, 2025 are as follows:
