Councilmember Raul Peralez offered a substitute motion, moving both staff memos and allowing staff to return with a more complete analysis. Councilmember Sergio Jimenez seconded the motion. Following discussion, they agreed to include a recommendation from staff as indicated below in "Action".

<u>Motion</u>: Councilmember Sergio Jimenez moved approval of the ordinance he coauthored with Councilmember Sylvia Arenas, dated April 14 2017. Councilmember Donald Rocha requested that the motion include direction to Housing to return to Council with a workplan to evaluate whether duplexes should be added to the ARO. Councilmember Sergio Jimenez agreed to the recommendation. Councilmember Donald Rocha seconded the motion.

Extensive discussion followed.

Councilmember Chappie Jones offered a substitute motion, regarding staff's 'alternative enrollment', to provide automatic enrollment after ten months, removing exemptions with unit subsidies. Mayor Sam Liccardo seconded the motion.

On a call for the question, the substitute motion failed. (5-6. Noes: Arenas, Carrasco, Jimenez, Nguyen, Peralez, Rocha.)

Action: On a call for the question, the joint memorandum from Councilmember Sergio Jimenez and Councilmember Sylvia Arenas, dated April 14, 2017, was approved as amended, to: (1) Adopt Staff Policy Alternative # 2: Implement an Ordinance with Just Cause Eviction Requirements with automatic enrollment for all tenants covered by that Alternative, with an ordinance to be considered at the Council Meeting of May 9, 2017, declining staff's recommendation Number 1 in its memorandum dated April 7, 2017. (2) Adopt staff recommendations 2-4 in the memorandum dated April 7, 2017, with the amendment as outlined in the April 14, 2017 memorandum from Councilmember Donald Rocha and Peralez, directing Staff to prepare a policy for Council consideration when they return to Council with a final Apartment Rent Ordinance in August: Tying the annual allowed rent increase for rent controlled units to the Consumer Price Index and allowing banking, consistent with the original staff recommendation for item 4.1 at the April 19, 2016 City Council meeting; additionally, (3) Return with an Urgency Ordinance ASAP for immediate implementation of Full Just Cause with automatic enrollment for all tenants covered by Alternative #2.
