A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE AUTHORIZING THE CITY MANAGER OR HER

DESIGNEE TO ACCEPT THE ROUND TWO BUILDING FORWARD LIBRARY INFRASTRUCTURE GRANT AND NEGOTIATE AND EXECUTE A GRANT AGREEMENT

WITH THE CALIFORNIA STATE LIBRARY FOR A TOTAL AWARD OF \$8,283,306 TO FUND ELIGIBLE PROJECTS

AT THE DR. MARTIN LUTHER KING JR. LIBRARY

WHEREAS, the City of San José's ("City") San José Public Library ("SJPL") is

comprised of the main Dr. Martin Luther King Jr. Library ("King Library") and 24 library

branches throughout the City; and

WHEREAS, the State of California Budget Act of 2022 (AB 178) and/or the Budget Act

of 2023 (SB 101) allocated grant funds for the Building Forward Library Infrastructure

Program Round 2 to address life-safety and critical maintenance needs of public library

facilities throughout California, projects that improve energy efficiency and sustainability,

and expand access digitally and physically, specifically for jointly operated library

facilities, and prioritized for high poverty areas of the state; and

WHEREAS, the California State Library has been delegated the responsibility for the

administration of this grant program, establishing necessary procedures; and

WHEREAS, said procedures established by the California State Library require a

resolution certifying the approval by the City Council either prior to execution of the

grant agreement; and

WHEREAS, per the California Poverty Index, King Library serves populations with high

poverty measurements; and

WHEREAS, City and San Jose State University ("SJSU") jointly operate King Library;

and

WHEREAS, City and SJSU have a plan detailing critical improvements for King Library

("Capital Overlay Plan"); and

WHEREAS, in Fall 2023, City applied for and California State Library awarded

\$8,283,306 in Building Forward Library Infrastructure Program Round 2 Funding for the

following projects, as further described in the King Library Capital Overlay Plan

(collectively, the King Library Projects"):

1. Modernizing Existing Elevators

2. Library Lighting Retrofit

3. Library HVAC Controls Renewal

4. Replacement of Front Entrance Doors; and

WHEREAS, Building Forward Library Infrastructure Program Round 2 Funding requires

a local match of 75%, resulting in a total required City match of \$6,212,479 for the King

Library Projects; and

WHEREAS, the City will enter into an agreement with the State of California to carry out

the King Library Projects; and

WHEREAS, City proposes to implement the King Library Projects; and

WHEREAS, City has the legal authority and is authorized to enter into a grant

continues to provide a safe, well-maintained environment for the public's exploration,

learning, and discovery;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN

JOSE THAT:

1. Pursuant and subject to all of the terms and provisions of the California Budget Act

of 2022 and/or the California Budget Act of 2023, the City Manager or designee is

hereby authorized and directed to prepare and file required documents related to

grant funding with the California State Library, and take such other actions

necessary or appropriate to obtain grant funding; and

2. The City Manager or designee is hereby authorized to negotiate and execute the

grant agreement with the California State Library, and any amendments thereto, for

\$8,283,306 in Building Forward Library Infrastructure Program Round 2 Funding for

the King Library Projects; and

3. The City Manager or designee is hereby authorized and directed to submit any

required documents, funding requests, and reports required to obtain grant funding

for the Building Forward Library Infrastructure Program Round 2 Funding for the

King Library Projects; and

4. Certifies that the King Library Projects will comply with any laws and regulations

including, but not limited to, the California Environmental Quality Act (CEQA), legal

requirements for building codes, health and safety codes, the California Labor Code,
