**WHEREAS**, "Free Use" does not apply to events which occur on a Saturday, and, therefore, Council approval is necessary to authorize free use of the City Hall Rotunda for the Neighborhood Forum on Saturday, June 7, 2025; and

WHEREAS, the City finds that the BeautifySJ Program's third Neighborhood Forum, "Collaborative Solutions for Homelessness in San Jose," is designed to inform residents about the City of San José's strategies for supporting unhoused individuals, and to provide attendees with the opportunity to engage with a panel of city leaders, ask questions, and learn about valuable resources to strengthen their neighborhoods, actively participate in their communities, and collaborate effectively with City government; and
