WHEREAS, Government Code section 66001(d) requires public agencies to make certain findings with regard to unfinished improvements for which fees were collected as a condition of development approval for a period of at least five years; and

WHEREAS, the City desires to accept the Report and make the required findings pursuant to Government Code section 66001(d);
