the Director of Finance on Sanitary Sewer Service and Use Charges and Storm Sewer

Service Charges for August 12, 2025, at 1:30 p.m., or as soon thereafter as the matter

may be heard; and

WHEREAS, pursuant to the San José Municipal Code Section 15.12.550 and
