## RECOMMENDATION

#### BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Berryessa Annual Art Festival will be held on May 11, 2019 at 3050 Berryessa Road, CA 95132 from 10:00 a.m. – 5:00 p.m. and is sponsored by Councilmember Lan Diep. Formerly known as the Berryessa Art and Wine Festival, this event is the oldest and largest neighborhood festival in San José, featuring a wide variety of food, beverages, entertainment, and locally made arts and crafts. Organized by the Berryessa Business Association and Bay Area Community Services, all proceeds support the Berryessa Union School District. The festival begins at the Berryessa Community Center, opening into Penitencia Creek Trail and Penitencia Creek Park. This event is free and open to the public.
