BACKGROUND

Kiwanis Club of Almaden Valley is working with the District 10 Council office, to plan a Montevideo neighborhood beautification day on June 15, 2019. Volunteers from the Kiwanis Club, Almaden Super Lions Club and Boys Team Charity will be working to help the surrounding neighborhood residents dispose and recycle their trash. In addition, the District 10 office will provide dumpsters, taking advantage of the \$18,000 budgeted in the FY 2018-2019 Operating Budget for community cleanups and dumpster days throughout District 10.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Johnny Khamis will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1).
