SUBJECT: APPROVAL OF ASIAN AMERICAN AND PACIFIC ISLANDER MONTH 2026 FESTIVAL SPONSORED BY COUNCIL DISTRICTS 1 AND 3 AS A CITY COUNCIL SPONSORED SPECIAL EVENT TO EXPEND CITY FUNDS AND ACCEPT DONATIONS OF MATERIALS AND SERVICES FOR THE EVENT

RECOMMENDATION

1. Approve the Asian American and Pacific Islander Month Festival scheduled on May 13, 2026, as a City Council sponsored Special Event and approve the expenditure of funds.
2. Approve and accept donations from various individuals, businesses, or community groups to support the event.
3. Place the item on the March 17, 2026, Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The 2026 Asian American and Pacific Islander Month Festival will be held on May 13, 2026 at San José City Hall Rotunda and sponsored by Councilmember Anthony Tordillos and Councilmember Rosemary Kamei. This special event celebrates Asian and Pacific Islander Month by raising awareness of the cultural and historical importance of Asian

communities¹ in the City of San José. This special event is dedicated to fostering an inclusive and supportive community, ensuring that Asian American and Pacific Islanders are celebrated and recognize as an important part of our city. San José is home to a large and diverse Asian and Pacific Islander (AAPI) community, which includes one of only three Japan Towns in the United States² and the largest Vietnamese population outside of Vietnam. This special event celebrates AAPI Month by featuring performances, Asian cuisine, and a resource fair supported by Asian organizations. The event is free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Anthony Tordillos and Councilmember Rosemary Kamei will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council Districts 3 and 1, City departments, and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.

PUBLIC OUTREACH/INTEREST

The Office of the City Clerk will post the item on the City's Website for the March 11, 2026, Rules Committee Agenda and the March 17, 2026, Council Agenda.
