#### RECOMMENDATION

Adopt a resolution authorizing the City Manager or her designee to negotiate and execute the first amendment to the Agreement for Network and Integrated Systems for the San José Mineta International Airport with Amadeus Airport IT Americas, Inc. (Orlando, FL), formerly known as Air-Transport IT Services Inc., to

- (a) Add two one-year options to extend the term of the agreement for a total of five options to potentially extend the term of the Agreement to June 30, 2027;
- (b) Increase the maximum compensation by \$8,000,000 for a combined total of \$27,549,241, subject to appropriation of funds; and
- (c) Add relevant Information Technology security requirements to comply with new Transportation Security Administration regulations.

### **SUMMARY AND OUTCOME**

Approval of this recommendation will ensure the continuance of maintenance and support for business-critical integrated systems and equipment at the San José Mineta International Airport (Airport) until a competitive solicitation is completed and a new agreement is in place.

#### **BACKGROUND**

In February 2006<sup>1</sup>, City Council authorized staff to negotiate and execute an agreement with Air-Transport IT Services Inc. to purchase and support shared-use technology for gates, ticket counters, and systems used to communicate airline activities to Airport staff and the public (Integrated Systems) to support the Airport's current and future operations. The Integrated Systems include an Airport operational database, a multi-user flight information display system, a passenger messaging system, a common-use passenger processing system, a resource management system, a local departure control system, and common-use self-service kiosks.

The agreement was awarded pursuant to a competitive Request for Proposals process and resulted in the purchase, installation, and configuration of the Integrated Systems. Since the execution of the agreement in 2006, City Council has approved multiple actions and amendments to extend the terms of the agreement<sup>2</sup> and expand the scope of work.

## **ANALYSIS**

As part of the Airport's shared-use business model, the Airport provides airlines and tenants with technologies and applications to manage their operations. The Integrated Systems provided and maintained by Amadeus Airport IT Americas, Inc. are the backbone for this business model. Many of these applications operate on Amadeus Airport IT Americas, Inc., a proprietary software platform, enabling seamless integration between the various systems.

The Airport operates seven days per week, 24 hours a day, and 365 days per year. The Integrated Systems, along with the underlying network and technical infrastructure, are mission-critical and must function 100% of the time.

Negotiating and executing an extension for both the Integrated Systems and the integrated network will allow the Airport to address additional requirements, such as enhanced cybersecurity measures and on-call technical expertise. These additional requirements are largely driven by a new federal directive from the Transportation Security Administration, which mandates airports to implement a cybersecurity critical infrastructure plan. The on-call technical expertise element will provide the Airport with

access to specialized experts to perform critical tasks as needed for information technology, cybersecurity, and infrastructure needs.

Staff intends to conduct a competitive solicitation to procure a new agreement for the provision of these services and indeed is currently working on gathering the initial requirements for the solicitation. The requested amendment will ensure continuity of operations while affording staff sufficient time to complete the competitive solicitation.

# **EVALUATION AND FOLLOW-UP**

The memorandum will not require any follow-up from staff.

## **COST SUMMARY/IMPLICATIONS**

The recommended agreement amendment amount of \$8.0 million will be funded by the Airport Maintenance and Operation Fund. Of the \$8.0 million increase, a total cost of \$3,921,136 is to be expensed in 2025-2026, and the remaining amount is subject to the appropriation of funds in 2026-2027.
