# 2.9 San José Clean Energy Non-Residential Customer Energy Services.

Adopt a resolution amending San José Clean Energy service offerings to include the following service offerings for non-residential customers:

(a) Establish a San José Economic Development Rate set at 12% below Pacific Gas and Electric Company's bundled service generation charges, inclusive of the Power Charge Indifference Adjustment and Franchise Fee Surcharge that will be offered to ratepayers approved to receive PG&E's Economic Development Rate; and

(b) Establish a Green Transportation Product that offers 100% emissions-free power at a discounted rate of \$0.005 per kilowatt-hour to public transportation accounts serving guided rail traction power facilities.

## 4.1 Cannabis Regulation of Tobacco Retailers Status Report.

As recommended by the Public Safety, Finance and Strategic Support Committee on April 18, 2024, accept the status report on the possibility of expanding the San José Police Department Division of Cannabis Regulation's responsibilities to include regulating licensed tobacco retailers.

Councilmember Peter Ortiz requested information regarding the differences between criminal and administrative citations and addressed the memorandum he submitted.

<u>Action</u>: Upon motion by Councilmember Peter Ortiz, seconded by Councilmember Dev Davis, and carried unanimously, the status report on the possibility of expanding the San José Police Department Division of Cannabis Regulation's responsibilities to include regulating licensed tobacco retailers was accepted.

While completing this, analyze the feasibility of placing a cap on Conditional Use Permits or other permit for this use while staff works to develop either proposed new cost recovery fees and resources or general funding streams and resources to build out a program in either Code Enforcement or the San José Police Department Division of Cannabis Regulation's to include regulating vape and smoke shops.

b.) Return to the Public Safety, and Strategic Finance Committee by end of 2024 (or after new year) with an update on these efforts. (11-0-0)
