The Coyote Meadows Coalition is a group of trail and park advocates working to create an urban openspace at the vacant lot at Story and and Senter Roads. This lot once known as "The Jungle" is the junction point for the Coyote Creek Trail, the future Five Wounds Trail and the planned Three Creeks Trail. Our coalition enthusiastically supports Staff's recommendation to purchase, at no cost (other than closing costs), lands and recreational trail easements from the Valley Transportation Authority (VTA). These lands and easements will enable the City to construct over 2 miles of off-road trail in eastern San José.

The Five Wounds Trail is of regional significance:

- Five Wounds Trail can connect to existing and planned segments of the Three Creeks Trail, Los Gatos, Guadalupe, Bay, and Coyote Creek Trails to form what we in the community are calling "The City Loop Trail."
- Five
- Wounds Trail, Coyote Creeks Trail and the planned eastern section of the Three Creeks trail all intersect at Coyote Meadows, the proposed urban open space that will create a second grand park for San Jose.
- The trail
- also will connect D7 to downtown, Little Portugal and Alum Rock Communities.

Our coalition is very excited for the Five Wounds Trail to be completed. It will be a wonderful addition to the city of San Jose.
