MUNI WATER EXISTING FACILITY

- Existing Facility
 - Three existing staff workspaces: converted equipment garage, temporary office trailer, administration building
 - Water system operations control center
 - Water quality room
 - Communications tower and equipment
 - Onsite water wells and backup power generation
 - Meter shop, hazmat storage, specialty utility equipment, City fleet, welding equipment, miscellaneous emergency and replacement water appurtenances, and electrical/instrumentation facilities
- Site improvements needed: deteriorating infrastructure, seismic/structural upgrades, mechanical improvements, investments to address staff health and safety, and implementation of net-zero carbon objectives





MUNI WATER ADMINISTRATIVE & OPERATIONS BUILDING PROJECT DEVELOPMENT


- Public Works led 2019 study (IBI Group)
 - Tuers Road Site Improvements three options:
 - ☑ Purchase/remodel existing commercial/warehouse building
 - ☑ Purchase vacant land and build new
 - ⇒ Rebuild onsite (selected)

New facility designed by Studio G Architects (2020-present)

• Project includes the construction of:

■ Two-story office building: 22,280 square feet

- Storage building: 6,000 square feet
- Sitework including:
 - * New communication tower and pad
 - * New parking lot
 - * New emergency generator







MUNI WATER PROJECT AWARD



- Project Timeline:
 - ✓ Bid Advertisement: April 2023
 - ✓ Bid Opening: June 15, 2023
 - ⇒ City Council Authorization to Award: June 20, 2023
 - Contract Award: July 2023
 - Construction Duration: Sept 2023 to Sept 2025
- City Council Authorization to Award:
 - Enable contract to be executed while City Council is in recess
 - Enable construction of Project to be completed prior to lease expiration of ESD temporary facility
- Engineer's Estimate:
 - Base Bid: \$33,230,000
 - Bid Alternate 1: \$450,000
 - Bid Alternate 2: \$2,145,000





MUNI WATER PROJECT FINANCING

- Short-Term
 - Issue Tax-Exempt Commercial Paper Notes by City of San José Financing Authority (CSJFA)
- Long-Term
 - Refund Tax-Exempt Commercial Paper (CP) Notes with future lease revenue bonds





COMMERCIAL PAPER PROGRAM

- A City-wide flexible short-term lease financing program started in 2004
- Pledged Assets
 - Tech Museum

Fire Stations I and 3

- Police Communications Center
- Animal Care Center
 South San José Police Substation
- Secured by direct-pay Letter of Credit from US Bank until March 2025
- CSJFA can issue up to \$175.0 million of CP Notes
- Each CP Note may be outstanding up to 270 days
- Maturing notes can be paid off fully, partially, or "rolled" to another maturity date
- Outstanding CPs are amortized up to 7 years after project completion
- CP Notes issuance requires Two-Thirds Vote (8) by the City Council





COMMERCIAL PAPER PROGRAM – BENEFITS VS. RISKS

Benefits

- Short-term financing with amortization flexibility
- Alternative to other medium term (7-10 years) financing vehicles
- Lower cost of funds
- No additional liens on improvements being financed

Risks

- Letter of Credit renewal
- Variable interest rate
- Letter of Credit bank downgrade
- Marketability

JOINT CITY COUNCIL/CSJFA FINANCING AUTHORITY BOARD RECOMMENDATION (ITEM 2)

- I) Conduct a public hearing in accordance with California Code Government Code Section 6586.5; and
- 2) Adopt a resolution of the CSJFA to approve and authorize the issuance of CSJFA CP Notes for \$40 million to finance the construction of the Muni Water Project, and reduce the authorization of CSJFA CP Notes for San José Clean Energy to \$75 million, further amending Authority Resolution No. 152, and authorizing other connected actions; and
- 3) Adopt a resolution of the City Council to approve and authorize the issuance of CSJFA CP Notes for \$40 million to finance the construction of the Muni Water Project and reduce the authorization of CSJFA CP Notes for San José Clean Energy to \$75 million, further amending Council Resolution No. 80125 and authorizing other connected actions.

CITY COUNCIL RECOMMENDATION (CITY COUNCIL ITEM 6.1)

- a) Adopt a resolution adopting the Initial Study/Mitigated Negative Declaration for the San José Municipal Water New Offices Project, and the related Mitigation Monitoring and Reporting Plan, in accordance with the California Environmental Quality Act.
- b) Adopt a resolution authorizing the Director of Public Works to:
 - Award and execute a contract for the construction of 9813 San José Municipal Water New Offices Project to the lowest responsive, responsible bidder in an amount not to exceed \$38,214,500;
 - 2) Decide any timely bid protest(s) and make the City's final determination as to the lowest responsive bidder that is responsible as needed to award the contract; and
 - 3) Approve a contingency of up to 15% of the amount of the construction contract for the Project.
