# 2.9 Lease Agreement Between the City of San José and Habitat for Humanity Silicon Valley for Its Continued Use of City-Owned Property Located at 1608 Las Plumas Avenue as a Restore Resale Outlet.

Adopt a resolution authorizing the City Manager or her designee to negotiate and execute a retroactive lease agreement and all documents necessary to effectuate the lease, between the City of San José, a municipal corporation of the State of California, as Landlord, and Habitat for Humanity Silicon Valley, a California nonprofit corporation, as Tenant, for its continued use of approximately 14,606 square feet of space at the City-owned property located at 1608 Las Plumas Avenue for an initial term of three years commencing July 1, 2024, and expiring June 30, 2027, at a rental rate of \$124,443.12 for the first year, \$128,176.44 for the second year, and \$132,021.72 for the third year, totaling \$384,641.28 for the initial term, with three mutual options to extend for an additional three years each at a rental rate that shall be determined and agreed upon by both parties.

# 2.10 Federal Highway Administration Grant Application for Public Charging Infrastructure.

Adopt a resolution authorizing the City Manager or her designee to file an application with the Federal Highway Administration for its Charging and Fueling Infrastructure Community Program grant; and if awarded, negotiate and execute a project agreement, and any related documents, for up to \$6 million in reimbursements from the Federal Highway Administration and up to \$1.5 million in City matching funds for a total project cost of up to \$7.5 million to install approximately 100 electric vehicle charging ports at City facilities for use by the public and City of San José fleet, commencing upon the date of the Federal Highway Administration's approval of award and the City's execution of an approved project agreement, with work to be scheduled to commence by no later than September 30, 2027.

Eric Schoennauer, representative of the applicant Hanover Company, offered the presentation and responded to questions. The applicant received five minutes to speak.

<u>Public Comment</u>: John, Rod Diridon Sr., Craig S., Ben Leech, Kelilah Federman, Doug Chasshire, Miguel Lopez, Sam Farb, Vanessa Hatakuyama, Nancy Okamoto, Mike Sodergren, Armando, Jordan Moldow, and Mario provided public comment. Raymond Costantino, Deputy Director, Parks, Recreation and Neighborhood Services, responded to questions.

Bill Schroh, Jr., President and CEO at History San Jose, responded to questions.

Motion: Councilmember David Cohen moved approval of the following:

• His *amended* memorandum dated August 13, 2024, with the following change to recommendation 3: "3. Encourage continued robust discussion regarding design of the park and how to make sure the park is designed in such a way as to pay tribute to the history of the Eiichi Sakauye family farm, his internment during WWII and his leadership in the San Jose community, *including the potential preservation of all or part of the house on site.*"

- The amended joint memorandum co-authored by Mayor Mahan, Councilmember Candelas, Councilmember Cohen, and Councilmember Ortiz, dated August 13, 2024 with the following change to Recommendation 2(a): "a. Work with NorCal Carpenters and other building trades, to make sure union contractors are informed of the availability of bid documents.
- Including the following amendment to Resolution No. RES2024-297, section 5 on page 26: "c. Finding: Alternative 5 would reduce the severity of Impact CR-1 and would eliminate the impact to the Sakauye house specifically. However, Impact CR-1 would remain significant and unavoidable because the other 6 structures that contribute to the eligibility of the potential historic district would still be removed. Although Alternative 5 would provide 4 fewer dwelling units than the Project, it would still have a density of approximately 81 du/acre and would therefore satisfy Project objective 2 by meeting the minimum density requirements for the North San José TERO. Because all other aspects of the Project would remain the same under Alternative 5, all other Project objectives would be met and all other impacts would remain the same. Additionally, Alternative 5 would present severe financing challenges to the Project, such that no reasonably prudent person would proceed with Alternative 5. The economic value of for-sale townhomes is a critical subsidy for the high infrastructure and land costs that cannot be absorbed by other Project elements, including high density multifamily units in the current economic environment. Eliminating a number of townhomes, as Alternative 5 requires, thus presents an insurmountable financing obstacle for the infrastructure needed for both the affordable and market rate rental units. Therefore, because Alternative 5 would not reduce any significant impacts to less than significant levels, would provide a Project with fewer housing units, and would render the Project economically infeasible, this alternative is rejected."
  - -Councilmember Bien Doan seconded the motion.

<u>Friendly Amendment</u>: Councilmember Omar Torres made a friendly amendment to modify Recommendation 2(c) of the joint memorandum co-authored by Mayor Mahan, Councilmember Candelas, Councilmember Cohen, and Councilmember Ortiz memorandum, dated August 13, 2024 to state as follows: c. Continue to cooperate with *Japanese American Museum of San José*, PAC\*SJ's and History San Jose's efforts to relocate the historic Sakauye Farmstead to History Park and contribute \$100,000 toward the cost of relocation. The friendly amendment was accepted by the maker of the motion and the seconder.

<u>Friendly Amendment</u>: Vice Mayor Rosemary Kamei made a friendly amendment to further modify Recommendation 3 of Councilmember Cohen's memorandum, dated August 13, 2024, to include the following: 3. Encourage continued robust discussion regarding design of the park and how to make sure the park is designed in such a way as to pay tribute to the history of the Eiichi Sakauye family farm, his internment during

WWII and his leadership in the San Jose community, <u>including the preference to keep</u> potential preservation of all or part of the house on site. The friendly amendment was accepted by the maker of the motion and the seconder.

Action: On a call to question, the motion carried unanimously, (a) **Resolution No. RES2024-297** (*with the amendment noted above regarding section 5 on page 26* of Resolution No. RES2024-297), (b) **Ordinance No. 31115**, (c) **Resolution No. RES2024-298**, and (d) **Resolution No. RES2024-299**, were adopted regarding the Planned Development Rezoning, a Vesting Tentative Map, and a Planned Development Permit on Certain Real Property Located at 0 Seely Avenue. Encourage continued robust discussion regarding design of the park and how to make sure the park is designed in such a way as to pay tribute to the history of the Eiichi Sakauye family farm, his internment during WWII and his leadership in the San Jose community, including the preference to keep potential preservation of all or part of the house on site.

Also including the amended joint memorandum co-authored by Mayor Mahan, Councilmember Candelas, Councilmember Cohen, and Councilmember Ortiz, dated August 13, 2024, including the following changes:

Accept the staff recommendation with the following amendments and additions:

- 1. Amend the mitigations for potential impacts to nesting birds to reflect:
- a. Surveys for migratory nesting birds shall be conducted by a qualified ornithologist or biologist no more than 14 days prior to any site disturbance or construction that starts during the entire nesting season between February 1 and August 31.
- b. The survey radii for migratory nesting birds surrounding the work area shall encompass 250 feet for passerines, 500 feet for small raptors, and 1,000 feet for larger raptors.
- c. If active nests are documented within the project area or in nearby surrounding areas, an appropriate buffer between the nest and construction activities should be established, marked, and maintained until the young have fledged and are foraging independently.
- 2. Require the developer to:
- a. Work with NorCal Carpenters *and other building trades*, to make sure union contractors are informed of the availability of bid documents
- b. Conduct traffic impact studies on the River Oaks area and provide up to \$450,000 in funding for traffic mitigation.
- c. Continue to cooperate with *Japanese American Museum of San José*, PAC\*SJ's and History San Jose's efforts to relocate the historic Sakauye Farmstead to History Park and contribute \$100,000 toward the cost of relocation. (10-0-1; Absent: Davis)
