Assembly Bill 481

- Approved by Governor on September 30, 2021
- Increase transparency, and oversight in the funding, acquisition, and use of military equipment
- Requires law enforcement agencies possessing such equipment to have policies and supporting information available to the public
- Approval from the governing body (City Council)
- Annual Report
- Public meeting

Category 1 Military Equipment

- Unmanned, remotely piloted, powered aerial or ground vehicles.
- 33 devices
- Annual cost - \$8,500
- Deployments - 199



Category 2 Military Equipment

- Mine-resistant ambush protected (MRAP) vehicles or armored personnel carriers
- 1 vehicle
- Annual cost - \$6,500
- Deployments - 3



Category 3 Military Equipment

- High mobility multipurpose wheeled vehicles (HMMWV), commonly referred to as Humvees, two and one-half-ton trucks, five ton trucks, or wheeled vehicles that have a breaching apparatus attached.
- 3 vehicles
- Annual cost - \$19,500
- Deployments - 30



Category 4 Military Equipment

- Tracked armored vehicles that provide ballistic protection to their occupants and utilize a tracked system instead of wheels for forward motion
- 0 vehicles



Category 5 Military Equipment

- Command and control vehicles that are either built or modified to facilitate the operational control and direction of public safety units
- 6 vehicles
- Annual cost - \$18,120
- Deployments - 48



Category 6 Military Equipment

- Weaponized aircraft, vessels, or vehicles of any kind
- 0 vehicles

Category 7 Military Equipment

- Battering rams, slugs, and breaching apparatuses that are explosive in nature
- Various dimensions and numbers
- Annual cost - \$6,262
- Deployments - 3



Category 8 & 9 Military Equipment

- Firearms and ammunition of .50 caliber or greater excluding shotguns
- Not currently possessed

Category 10 Military Equipment



- Specialized firearms and ammunition of less than .50 caliber, including assault weapons as defined in Sections 30510 and 30515 of the Penal Code
- 439 firearms
- Annual cost for firearms and ammunition - \$ 345,134
- Deployments - 0

Category 11 Military Equipment

- Any firearm or firearm accessory that is designed to launch explosive projectiles
- 8 firearms with attachments
- Annual cost - \$400
- Deployments - 3



Category 12 Military Equipment

- “Flashbang” grenades and explosive breaching tools, “tear gas,” and “pepper balls,” excluding standard, service-issued handheld pepper spray
- 1,336 pieces of equipment
- Annual cost - \$31,300
- Deployments - 27



Category 13 Military Equipment

- Taser Shockwave, microwave weapons, water cannons, and the Long Range Acoustic Device (LRAD)
- 7 pieces of equipment
- Annual cost - \$5,000
- Deployments - 13



Category 14 Military Equipment

- Projectile launch platforms and their associated munitions: 40mm projectile launchers, stun bag, rubber bullet, and specialty impact munition (SIM) weapons
- 256 launchers
- 3,356 munitions
- Annual cost - \$23,450
- Deployments - 16



Military Equipment Use Considerations

- Necessary because there is no reasonable alternative that can achieve the same objective of officer and community safety.
- Reasonably cost effective compared to available alternatives that can achieve the same objective of officer and community safety.
- Military equipment shall only be used by a Department employee only after applicable training, including any course required by the Commission of Peace Officer Standards and Training, has been completed, unless exigent circumstances arise.
