We ask that these plans be strengthened with designated financial and human resources and specific target deadlines.

Paying for electrification, while expensive, is much cheaper than paying for the costs of climate destabilization. [\\$545 million](#) is already being spent to shore up levees to protect north San José from flooding. Costs to build a seawall to protect the Embarcadero in San Francisco have been estimated at [\\$5 billion](#). Damage from California wildfires in the past few years has cost as much as [\\$10 billion](#) per fire.

Now is the moment to act for the climate. We are running out of time. There is widespread support in the South Bay for climate action, and the people of San José are counting on you to take the necessary steps to fulfill your pledge to reach net zero carbon emissions in our city by 2030. Since the energy used in buildings generates 20-30% of our region's greenhouse gas pollution, it's essential to adopt an ambitious plan to power our buildings with clean electricity, not fossil gas.

We are also looking to you to protect our children and other residents from the toxic chemicals emitted by gas appliances, particularly gas stoves. Studies have shown that children living in homes with gas stoves have up to 42% percent increased risk of developing asthma. Therefore, supporting residents to transition from gas to electric appliances is not only the right thing to do for the climate, it's the right thing to do for our health.
