III. Diridon Station Area Plan (DSAP) Amendment and Google Mixed-use Plan Update

Staff will provide an overview of the anticipated process to amend the Diridon Station Area Plan (DSAP), which City Council adopted in 2014. The City anticipates reviewing a proposal by Google for a mixed-use development project concurrently with the amendment process. This agenda item includes a brief presentation highlighting Google's approach to developing a mixed-use plan, including community engagement and timeline. IV. Diridon Integrated Station Concept Plan

The California High-Speed Rail Authority, Caltrain, City of San José, and Santa Clara Valley Transportation Authority (VTA) are working together on a Concept Plan to expand and redesign Diridon Station. The planning process began in fall 2018, and has included two rounds of outreach. The Concept Plan project team has presented to the SAAG on October 18, 2018 and March 11, 2019 (see meeting summaries at www.diridonsj.org/saag).

For this agenda item, staff will provide an update on progress completed to date, including preparation of three possible layouts for the future station. Following the presentation, the SAAG will have opportunity to ask questions and provide feedback on the layouts.
