

SAN JOSE, Calif (March 14, 2019) -- SAP Center at San Jose (@SAPCenter), the top-ranked arena in the Bay Area, will host a three-day music festival September 13-15 to mark the culmination of a year-long celebration of 25 years of SAP Center memories. Security Procedures at Excite Ballpark

The San Jose Giants were devastated by recent tragedies across our nation, including one in our backyard at the Gilroy Garlic Festival. Our hearts go out to all impacted by these terrible and senseless acts of violence.

The security and safety of fans at Excite Ballpark is our top priority. Without compromising the security protocol plan, the San Jose Giants wanted to share some details about existing and new security measures at the ballpark. Every home game, the San Jose Giants works closely with local agencies, including SJPD, SJFD and EMTs to ensure rapid response to any and all security and/or health concerns. If any of our fans have any safety or health concerns at the

ballpark, all staff members have been trained to contact an officer to assist. Fans who enter through the gates of Excite Ballpark will now walk through metal detectors and a bag check; we ask that fans remove all large metal items from their pockets before the screening process to ensure everybody can enter the ballpark safely and quickly. Before entering, fans are encouraged to check our website for a full list of prohibited items and leave those items in the car; prohibited items will be confiscated at the gate. Prohibited items include (but are not limited to): food items, non-water beverages, glass bottles or cans, chairs, sticks, clubs, squirt guns, airsoft rifles, laser pointers or weapons of any kind.

RE: SJDA Input on San Jose's Diridon Station Planning

Dear Liz,

The San Jose Downtown Association would like to thank you and the four partner agencies working on the Diridon Station concept plan for the significant community outreach that has been done around this project so far. We believe that the future Diridon Station will be an essential piece in making downtown San Jose vibrant, dense, and bustling. However, in order to ensure that Diridon is a major transportation hub and destination, we need to give thoughtful consideration to the design and use of the station not only today, but for future generations who will be the beneficiaries of a long-range strategic vision. We offer the following feedback at this first stage in the planning process.

Platform Position: We believe that the elevated rails (25 ft) will better allow for creative use of space underneath the tracks. It is essential that this space not become a blighted area, and to avoid this, we need to ensure this space becomes a nexus for commercial activity, increasing foot traffic in the station area and the attractiveness of San Jose as a tourist destination. Borough Market in London is an instructive example of this type of activation, as are Cologne Central Station and Central Station in Amsterdam of elevated intermodal facilities. Additionally, elevated tracks, as opposed to at-grade tracks, will allow for better traffic flow on the major streets that run east-west through downtown (e.g. Santa Clara St., San Fernando St., etc). We understand that the elevated tracks will also allow for removing dips from streets like Santa Clara, which would increase safety and provide pedestrians with a better walking experience.

Station Location: First and foremost, we feel that the station itself should be a destination for residents and visitors in addition to a transportation hub. This means that the station should be impressive, large, contain retail and dining options, and have several entrances, including on the west side, to make it as convenient as possible to use. It is critical to our Association that downtown is treated as a destination and not just a pass-through. An iconic station would help us achieve that goal. Furthermore, it is crucial that there is a seamless connection between the rail

services at Diridon and BART — where the transit rider can quickly transfer between the two and we maximize the user's experience during this transfer (e.g. public art/activation, retail, etc). This connectivity between rail and BART will be vital to ensuring riders can seamlessly move between transit modes and travel up Santa Clara St. through downtown. We also need a station that optimizes not only transit, but development around the station. Since the footprint of development around the station is still an unknown, we need to ensure that the chosen track alignment does not limit this future development — especially given our dire need for housing.

Light Rail: Given the opportunity we currently have to reimagine transportation in San Jose, we believe additional thought should be given to the future of light rail, particularly in downtown. We would like to see a thorough study done with the aim of determining the best light rail route (taking into account the different modes of transportation that will run through Diridon and downtown). Our hope is that such a study will result in less redundancy and a more efficient system that is faster and therefore, better utilized by public transit riders. Some of the specific issues we think should be considered are: reducing the number of light rail stops in downtown or rerouting the line altogether bypassing downtown with the exception of a single downtown light rail stop at Diridon Station, where riders could then connect to rail and BART. Such a decision would then free up sections of First and Second streets, which could become more pedestrian and bike friendly, resulting in increased commerce and vibrancy. We also suggest studying whether light rail could provide service between Diridon and the San Jose airport.

Connectivity to Downtown: We feel it is important to ensure the east-west roads into downtown remain open to cars, including Santa Clara St., San Fernando St., and Park Ave. We also believe these roads should accommodate pedestrians, cyclists, and other micro-mobility modes of transportation. However, keeping these roads open to cars will help us avoid unnecessary traffic congestion, which will become a larger issue as we have more people commuting through Diridon Station and to San Jose writ large. We do believe that pedestrian-only streets would help increase commercial activity and overall vitality in downtown San Jose, and also think this should be an important aspect of the City of San Jose's current downtown transportation study. Again, we would suggest considering sections of First and Second streets as potential pedestrian-friendly areas, akin to the iconic Las Ramblas in Barcelona -- a model of public space activation -- if there is a reconsideration of light rail through downtown.

Airport Connector: If San Jose is to truly be a transportation hub, then a connection from Diridon Station to the San Jose airport is a necessity and should be part of this planning process from initial stages, not an afterthought. We believe such a link will not only spur tourism and facilitate business in downtown but can also improve the area between Diridon and the airport. We should use the planning process to determine the best transportation mode to connect these two, while also spurring development and better utilizing public space along the corridor.

California High-Speed Rail Authority Receives Important Federal Approval

SACRAMENTO, Calif. – In another step toward continued progress on the nation's first high-speed rail system, today, the California High-Speed Rail Authority (Authority) announced that the State of California has received approval from the Federal Railroad Administration (FRA) to assume its federal environmental review responsibilities under the National Environmental Policy Act (NEPA) and other federal environmental laws. Today's announcement allows the Authority to move forward with the completion of the environmental reviews, as per our federal American Recovery and Reinvestment Act (ARRA) grant agreement, for the entire first phase of the high-speed rail program from San Francisco to the Los Angeles area.

"This is welcome news for the State of California and the High-Speed Rail program," said California State Transportation Agency Secretary, David Kim. "The ability for us to conduct this environmental review and move the project forward will enable momentum and continued progress on this transformative mobility project. We commend the FRA for taking this much-needed action."

"This action is an important milestone for the high-speed rail program," said Authority CEO Brian Kelly. "This allows the Authority to complete the environmental review process more efficiently, while still maintaining the same level of review with multiple opportunities for public input and collaboration. We've lost valuable time waiting with the FRA's disengagement, so I am very thankful for this action, and I am hopeful this step is the beginning of a more collaborative and cooperative relationship prospectively. We both gain from a strong partnership."

With NEPA assignment, the Authority will now approve environmental documents for the high-speed rail program, as the state already has authority to do for highway projects, while continuing to perform its lead agency responsibilities under the California Environmental Quality Act (CEQA). This will allow the Authority to continue construction progress in the Central Valley, and finalize route decisions throughout the state, while at the same time meeting its federal grant commitments, and maintaining critical environmental protections.

Executive Summary

On behalf of the Board of Directors and staff of the San Jose Arena Authority, we are pleased to submit the Fiscal Year 2018-19 Executive Summary of activities undertaken by the Arena Authority. Included in this Executive Summary are areas of responsibilities administered by the Arena Authority for its oversight of the management and operation of SAP Center at San Jose, Solar4America Ice at San Jose, and Excite Ballpark Home of the San Jose Giants. Additionally, there is information on the organization's leadership with the South Campus Operations Team (SCOT) and the Emergency Resources Network (ERN) as well as the Authority's community outreach programs.

Background

The Arena Authority was created by a resolution of the San Jose City Council and consists of a Mayor-appointed, 19-member Board of Directors. Since the Arena Authority's incorporation in 1990, the organization's administrative oversight has been broadly expanded to support these three regional sports facilities and the area south of San Jose State University. Pursuant to the terms and conditions of the 2019 Restated Agreement between the City and the Arena Authority, the terms were formally recast to reflect the Authority's expanding areas of oversight.

As a leading advocate for the comprehensive engagement regarding facility operations and safety, the Arena Authority introduced the Emergency Resources Network (ERN) in 2018. The general mission of the ERN is to enhance the collaborative relationships between facility operators and first responders in the preparation and response to natural disasters and man-made threats. In doing so, facility operators and public safety representatives have strengthened the collective effort in employing best practices in emergency response scenarios.

Additionally, per the terms of the City/Arena Authority agreement, the Authority serves as a City liaison to the community for the three facilities. As liaison, the Arena Authority administers a number of popular community-based programs. These programs include the Arena Ticket Distribution program, the SAP Center at San Jose City and Community Events program, the San Jose Sports Hall of Fame, and the San Jose Giants Community Ticket program. Details of these programs are included later in the summary.

Facility Operational Oversight

In overseeing facility operations at SAP Center at San Jose, the Arena Authority engages a number of City departments and other entities to facilitate the management of the Center's day-to-day operations. To that end, the Authority works collaboratively with City departments and SAP Center Management in the administration of a comprehensive SAP Center at San Jose Transportation and Parking Management Plan (TPMP). Through the regular implementation of this plan, critical vehicular traffic and pedestrian movement strategies, vicinity parking operations, public transit management issues, and neighborhood integrity concerns are addressed and managed in an efficient and well thought-out manner.

Furthermore, a series of expansive public transit projects are currently under development that will greatly impact – and ideally – enhance operations at the Center. These projects include the eventual arrival of the Bay Area Rapid Transit subway through Downtown San Jose, which will include an arena station; the design and function of the Autumn Parkway; the design of the California High Speed Rail; the electrification of Caltrain; and the design and operation of the multimodal transit center at the San Jose Diridon Station. Along with the Downtown Google property purchases, these projects will need to support the uninterrupted operation of the Center, including maintaining contractual on-site and off-site parking inventories throughout the length of project planning, construction and completion.

Another feature to the Arena Authority's role in overseeing operations of SAP Center at San Jose as well as Solar4America Ice at San Jose involves the Authority's development, implementation, and management of comprehensive capital budget programs. Working closely with Sharks Sports & Entertainment, the City Manager's Budget Office, and the Department of Public Works, the Arena Authority submits annual capital repair and replacement budgets to the City for review and approval. For the current fiscal year, the Arena Authority worked with the City and Sharks Sports & Entertainment to draft and submit capital budgets for SAP Center at San Jose (\$4,131,250) and Solar4America Ice at San Jose (\$1,612,000).

For Excite Ballpark Home of the San Jose Giants, the Arena Authority continues to concentrate on essential capital replacements and upgrades for the 77-year old stadium. During FY 2018-19, the City and the Giants agreed to replace the fencing along the right field line and install exterior cameras. With the recent restated agreement between the City and the San Jose Giants, the additional funding from the naming rights agreement (Excite Ballpark) will enhance the stadium capital reserve program.

Community Outreach Programs

The Arena Authority serves a critical function as the City's community liaison in identifying and addressing day-to-day operational issues at SAP Center at San Jose. To address any extraordinary elements to Center and vicinity operations, the Arena Authority works directly with the City's Departments of Transportation and Office of Cultural Affairs, the San Jose Police Department, and Sharks Sports & Entertainment to conduct outreach to local residents and business owners. This is accomplished through special notifications, direct public outreach, and participation in regional project meetings. One example is the Arena Authority's representation on the VTA's BART Silicon Valley Downtown/Diridon Community Working Group.

Last fiscal year was an active one for the Center. Besides the concerts, family shows and regular season games for the Sharks and Barracuda, SAP Center at San Jose hosted a number of prominent events. These events included the 2019 National Hockey League All-Star Game, the 2019 NCAA Men's Regional Basketball Tournament and the Stanley Cup (Sharks) and Calder Cup (Barracuda) Playoffs. These extraordinary events required significant planning among the City, SAP Center Management and the Arena Authority.

The Arena Authority puts significant effort into the administration of the popular Arena Ticket Distribution program. From a total inventory of 4,576 tickets available to the Arena Authority during FY 2018-19, the Authority distributed all of the tickets per the guidelines of City Council Policy 9-11. Since the ticket program was introduced in 1993, the Arena Authority has distributed over 120,000 tickets to the San Jose community. Some of the community-based programs/organizations that received tickets during the year included People Assisting the Homeless, LGBTQ Youth Space, City Peace Project, Family Supportive Housing, Project Hope, Trash Punx, Rocketship Schools and Project Hope.

Another active community program is the Arena Authority's City and Community Events program. During the last fiscal year, three service organizations implemented events at SAP Center at San Jose. From this activity, \$100,000 of City and Community Events program funding was allocated to program applicants to offset event expenses.

One of the approved City Events was the 24TH annual San Jose Sports Hall of Fame induction ceremony. As a program supporter, the Arena Authority maintains representation on the San Jose Sports Authority's Sports Hall of Fame Committee and participates in the selection of the annual inductees. The bronze plaques presented at the annual induction ceremony are eventually placed on permanent display along the public concourse at SAP Center at San Jose. To date, over 100 athletes and coaches have been inducted into the San Jose Sports Hall of Fame.

Working collaboratively with the San Jose Giants, the Arena Authority created program guidelines to ensure that complimentary San Jose Giants game tickets were made available to school districts throughout the city during the Giants regular season. During the 2018 season the Giants continued to make available up to 3,500 complimentary tickets to the San Jose community during the regular season.

The Arena Authority chairs the South Campus Operations Team (SCOT). Created by the Arena Authority in 2010 to provide a forum to share information and address operational conflicts, the team includes representatives from Kelley Park, Happy Hollow Park and Zoo, History Park, Solar4America Ice at San Jose, Excite Ballpark Home of the San Jose Giants, San Jose State University Athletics, the Office of Cultural Affairs, the Department of Public Works and the Arena Authority. On a regular basis the South Campus park and facility operators convene to share event schedules and highlights, address event management and parking issues, work jointly in managing simultaneous events and discuss capital projects. The south campus area continues to be a popular destination as nearly three million people visited San Jose's south campus area during the last fiscal year.

As this summary illustrates, the Arena Authority continues to work cooperatively to ensure that these City-owned assets are managed and operated in a fashion consistent with other first-class sports and entertainment facilities. After 25 years SAP Center at San Jose continues to be recognized as one of the finest sports and entertainment venues in North America. Solar4America Ice at San Jose is one of the most active ice facilities in the United States. And after over 75 years of operation, Excite Ballpark Home of the San Jose Giants continues to be considered a treasured community asset. The Arena Authority is dedicated to keeping these City-owned facilities as major regional attractions for sports, recreation, and entertainment.

RESTATED AGREEMENT BETWEEN THE CITY OF SAN JOSE AND THE SAN JOSE ARENA AUTHORITY

THIS RESTATED AGREEMENT (hereinafter "Agreement") is entered into this _25 day of _____, 2019, between the CITY OF SAN JOSE, a municipal corporation of the State of California (referred to herein as "CITY") and the SAN JOSE ARENA AUTHORITY, a nonprofit corporation of the State of California (referred to herein as "AUTHORITY").

RECITALS

WHEREAS, in June 1990, the CITY approved the creation and funding of AUTHORITY as a nonprofit corporation formed to oversee operation and management of the San José Arena facility, now known as SAP Center at San Jose (referred to as "Arena") on behalf of the CITY; and

WHEREAS, on October 24, 1991, the City Council approved an agreement between the CITY and AUTHORITY to further these purposes; and

WHEREAS, on December 19, 2000, CITY and San Jose Arena Management ("SJAM") entered into an Amended and Restated San Jose Arena Management for the management and operation of the Arena and related facilities; and

WHEREAS, on May 25, 2004, CITY and SJAM entered into an Amended and Restated Lease and Management Agreement in which the CITY designated to the AUTHORITY certain general management responsibilities of the CITY-owned ice center now known as Solar4America Ice at San Jose ("Ice Facility"); and

WHEREAS, on September 26, 2006, CITY and AUTHORITY entered into a Restated Agreement updating the agreement executed in 1991 to add additional responsibilities and provide for AUTHORITY staff through the use of CITY employees; and

WHEREAS, on December 17, 2013, the City Council approved an Agreement between the CITY and Baseball Acquisition Company, Inc. ("Stadium Management Agreement") In which the CITY delegated to the AUTHORITY certain management agreement responsibilities for San Jose Municipal Stadium "Baseball Stadium"); and

WHEREAS, on August 15, 2018, the CITY entered into a Second Amended and Restated Arena Management agreement, and a fourth Amendment to the Amended and Restated Lease and Management Agreement, extending the term of each agreement to 2025, with an option to extend the term to 2040; and

WHEREAS, on March 23, 2004, the City Council approved an agreement between the CITY and San José Arena Management Corporation in which the CITY had delegated to the AUTHORITY certain general management responsibilities of Logitech Ice at San José (referred to as "Ice Facility"); and

WHEREAS, CITY and AUTHORITY desire to restate the 2006 Restated Agreement to align with the Term of the Second Amended and Restated Arena Management Agreement and the Fourth Amendment to the Amended and Restated Lease and Management Agreement and to recognize the additional responsibilities undertaken by AUTHORTY related to the Public Ice Facility and Baseball Stadium.

NOW, THEREFORE, for and in consideration of the mutual promises, covenants and agreements hereinafter set forth, the parties do hereby agree as follows:

SECTION 1. DEFINITIONS.

Unless otherwise defined herein or the contract otherwise requires, the capitalized terms used herein shall have the meanings specified in the Second Amended and Restated San José Arena Management Agreement ("Arena Management Agreement") and the Amended and Restated Lease and Management Agreement Regarding the Ice Centre ("Ice Centre Agreement") (collectively the "Management Agreements"), by and between the CITY and San José Arena Management Corporation LLC ("Manager"). Additionally, the capitalized terms used herein shall also have meanings specified in the Amended and Restated Agreement between the CITY and the Baseball Acquisition Company, Inc. for oversight of the operation of the Baseball Stadium.

SECTION 2. TERM OF AGREEMENT.

The term of the Agreement shall be from the date of execution by the CITY to June 30, 2025, inclusive, unless terminated earlier pursuant to Section 8 below. The City has the option to extend the agreement until June 30, 2040 in alignment with the term of the San Jose Arena Management Agreement.

SECTION 3. SERVICES PROVIDED BY CITY.

CITY agrees during the term of this Agreement to perform the following duties:

A. CITY will fund the AUTHORITY at a level to support AUTHORITY staff, operations and programs as well as Board of Directors areas of responsibilities. Funding will be based in part on the level of AUTHORITY'S areas of oversight and administration. In conference with the AUTHORITY, CITY will provide regular, sufficient funding, as deemed appropriate by CITY to support the ongoing operation of the AUTHORITY, including funding to support an executive staff, Board of Directors meetings, activities and other organizational functions, responsibilities and programs. Besides annual cost of living (COLA) adjustments

that CITY will endeavor to provide, CITY funding can be further augmented to align with the various responsibilities undertaken by the AUTHORITY. Additionally, CITY recognizes the AUTHORITY'S expanding areas of responsibilities and will take this issue into consideration for future funding increases to support expanding AUTHORITY responsibilities and oversight.

B. Provide administrative support to address Arena Authority operations and oversight through the appropriate City departments, including but not limited to, the City Manager's Office, the City Attorney, the Department of Transportation, the Department of Public Works, the Fire and Police Departments and the Office of Emergency Management.

SECTION 4. SERVICES PERFORMED BY AUTHORITY.

AUTHORITY agrees during the term of this Agreement to perform a number of oversight duties on behalf of the CITY as the CITY deems appropriate in its sole and absolute discretion and shall engage in the following activities:

- A. Monitor the implementation of the terms and conditions set forth in the 2018 Second Amended and Restated Arena Management Agreement and the First Amendment to the Second Amended and Restated Arena Management Agreement.
- Oversee the management and operation of SAP Center at San José on behalf of the CITY.
- C. Monitor the implementation of the terms and conditions set forth in the 2004 Amended Lease and Management Agreement for the Ice Centre of San Jose (Solar4Amercia Ice at San Jose).
- D. Oversee the management and operation of Solar4Amercia Ice at San José as set forth in the Ice Centre Agreement.
- E. Monitor the implementation of the terms and conditions set forth in the 2019 Amended and Restated Agreement for San Jose Municipal Stadium.
- F. Oversee the management and operation of San Jose Municipal Stadium, the Minor League Baseball stadium.
- G. Act as CITY's liaison to the San José community concerning neighborhood impacts in the operation of the Arena, the Ice Facility and the Baseball Stadium (Collectively, the Facilities).
- H. Administer the City and Community Events Program Policy and fund as set forth in the Arena Management Agreement.

- I. Oversee the planning and implementation of the annual facilities capital budgets as determined in the three Facilities management agreements.
- J. Serve as the liaison between the Managers of the Facilities, City Administration and the City Council.
- K. Develop and submit an annual AUTHORITY program-operating budget to CITY to coincide with the CITY's established budget process.
- L. Administer the use of the CITY executive suite (Arena Suite C-11) and lower section seating tickets (including parking passes) provided to the CITY under the terms of the Arena Management Agreement and in accordance with the policies for distribution as may be adopted by City Council Policy 9-11, "Distribution of Tickets or Passes to City/Agency Officials", as may be amended from time to time.
- M. Accept an annual report on the Ice Facility and provide report to the CITY, including information on facility projects, programs and capital improvements.
- N. Serve as the facilitator to the South Campus Operations Team (SCOT) in the ongoing operations and activities of CITY-owned facilities and University-owned facilities in the south campus area of San Jose State University.
- O. Prior to November 1 of each year, the AUTHORITY shall submit an annual executive summary to the CITY regarding previous fiscal year operations of the arena, ice facility and baseball stadium facilities as in accordance with the term of the three management agreements. Included in the annual executive summary will be a report on AUTHORITY programs, including the Arena Ticket Distribution Program, the City and Community Events Program, the facilities' capital budget program and operations undertaken by the South Campus Operations Team.
- P. By request of the CITY, participate in the ongoing development meetings and discussions held by the CITY relating to arena-vicinity transit and development projects, including but not limited to, the Bay Area Rapid Transit (BART), High Speed Rail, the Autumn Parkway, arena on-site and off-site parking inventories, traffic management strategies, the San Jose Diridon Transit Center and the Google campus properties.
- Q. Participate in the discussions and planning held by the CITY in relation to the ongoing development in the south campus area.
- R. Serve as the facilitator for the City's Emergency Resources Network and work with the appropriate CITY representative and facility operators in the development of a comprehensive emergency network.

- S. Participate in the administration of and updates to the comprehensive Arena Transportation and Parking Management Plan.
- T. From time to time, participate in other CITY-directed projects or programs in furtherance of CITY program and project development.
- U. Continue to expand its areas of oversight to support and enhance CITY operations, including the planning and development in the Arena/Diridon Station area, the planned expansion of Solar4America Ice at San Jose, and the development of the south campus area

Nothing herein shall authorize the AUTHORITY to enter into any agreement on behalf of the CITY or which (1) would cause any part of the revenues received by the CITY under the Arena Management Agreement to be reduced; or (2) would materially increase the financial obligations of the CITY in connection with the construction, operation or use of the arena, ice training facilities or baseball stadium.

SECTION 5. CITY FUNDING.

- A. Funds provided by the CITY to the AUTHORITY will be issued by check no later than July 15 of each fiscal year of this agreement.
- B. For Fiscal Year 2019-20, CITY will fund the AUTHORITY base funding of \$227,630 and an additional \$49,955 for oversight for Solar4America Ice at San Jose for a combined funding total of \$277,585.
- C. CITY and AUTHORITY will confer from time to time to address funding levels to adequately support AUTHORITY operations that benefits CITY, taking into consideration services performed by AUTHORITY as described in Section 4.

SECTION 6. INSURANCE REQUIREMENTS. AUTHORITY shall maintain the following insurance coverage for the term of this Agreement.

- A. A COMMERCIAL GENERAL LIABILITY policy with minimum limits of One Million Dollars (\$1,000,000) combined single limit for bodily injury and property damage and provide at least the following minimum coverages:
 - 1. Premises Operations;
 - Broad Form Property Damage, including advertising injury liability;
 - 3. Broad Form Contractual Liability;
 - 4. Completed Operations;
 - 5. Products Liability;

- 6. Personal Injury (Coverage A, B, & C);
- 7. Fire Legal Liability in an amount not less than Fifty Thousand Dollars (\$50,000), or in such amount as the CITY shall specify;
- 8. Employers non-ownership (automobile): \$2,000,000 each occurrence.
- B. A WORKERS' COMPENSATION AND EMPLOYER'S LIABILITY POLICY to provide coverage for any and all employees of AUTHORITY:
 - 1. This coverage shall be written in accordance with the laws of the State of California and for the statutory limits associated therewith.
 - 2. This coverage shall provide for Workers' Compensation (Coverage A).
 - 3. This coverage shall also provide for a minimum of \$100,000 Employers¹ Liability (Coverage B).

C. EXCEPTION.

If, however, AUTHORITY does not have any employees AUTHORITY shall sign the following statement as well as the contract itself to effect a fully initiated contract:

The herein designated AUTHORITY, does not have, nor intends to have for the full term of this Agreement, any employees. Furthermore, AUTHORITY does not wish to obtain or be covered under any Workers' Compensation insurance coverage and, therefore, is signing this statement in lieu of providing the above required Workers' Compensation Coverage.

 - 1. "The City of San José, their employees, officers, agents and contractors are hereby added as additional insured."

- 2. "This policy shall be considered primary insurance as respects any other valid and collectible insurance the City of San José may possess, including any self-insured retention the CITY may have, and any other insurance the CITY does possess shall be considered excess insurance only."
- 3. "This insurance shall act for each insured, and additional insured as though a separate policy had been written for each. This, however, will not act to increase the limit of liability of the insuring company."
- 4. "Thirty (30) days prior written notice shall be given to the City of San José in the event of cancellation, reduction in coverage, or non-renewal of any nature. Such notice shall be sent to:

- Endorsement #4 (30 days notice) listed above is the only endorsement required to be made a part of the Workers¹ Compensation and Employers¹ Liability policy.
- F. PROOF OF COVERAGE: Copies of all the required ENDORSEMENTS shall be attached to the CERTIFICATE OF INSURANCE which shall be provided by the AUTHORITY's insurance company as evidence of the stipulated coverages. This Proof of Insurance shall then be mailed to:

SECTION 7. INDEMNIFICATIONS.

A. INDEMNIFICATION BY CITY. CITY shall defend, indemnify and hold harmless the AUTHORITY, its officers, agents, directors and employees, from and against all claims, suits, actions, causes of action or liability of any kind, nature or description, brought by any and all persons for or on account of any loss, damage, death of or injury to persons, property or any interest, tangible, or intangible, sustained by or accruing to any person or persons, howsoever the same may be caused, directly or indirectly arising or resulting from the performance or obligations of the AUTHORITY under this Agreement or the failure of AUTHORITY to perform under this Agreement, except as may arise

- from the gross negligence or willful default of AUTHORITY, its officers, agents, directors and employees.
- B. INDEMNIFICATION BY AUTHORITY. AUTHORITY shall defend, indemnify and hold harmless the CITY, its officers, agents, directors and employees, from and against all claims, suits, actions, causes of action or liability of any kind, nature or description, brought by any and all persons for or on account of any loss, damage, death of or injury to persons, property or any interest, tangible, or intangible, sustained by or accruing to any person or persons, howsoever the same may be caused, directly or indirectly arising or resulting from the performance or obligations of CITY under this Agreement or the failure of CITY to perform under this Agreement, except as may arise from the gross negligence or willful default of CITY, its officers, agents, directors and employees.

SECTION 8. TERMINATION OF CONTRACT FOR CONVENIENCE,

This Agreement may be terminated by CITY whenever CITY in its sole and absolute discretion determines that such termination is in the best interests of the CITY. Any such termination shall be effected by delivery to AUTHORITY of a notice of termination. Upon receipt of such notice of termination, AUTHORITY shall cease conducting all operations under this Agreement as are otherwise permitted or allowed and shall immediately return to CITY all CITY funds in AUTHORITY's possession or control, except that AUTHORITY shall be allowed to retain sufficient funds to wind up the affairs of the AUTHORITY.

SECTION 9. GIFTS.

- A. AUTHORITY is familiar with CITY's prohibition against the acceptance of any gift by a CITY officer or designated employee, which prohibition is found in Chapter 12.08 of the San José Municipal Code.
- B. AUTHORITY agrees that its officers, directors and employees shall be bound by the provisions of Chapter 12.08 of the San José Municipal Code.

SECTION 10. NOTICES AND COMMUNICATIONS.

All notices and other communications required or permitted to be given under this Agreement shall be in writing and shall be personally serviced or mailed, postage prepaid and return receipt requested, addressed to the respective parties as follows:

Unless otherwise authorized by this Agreement, amendments to the terms and conditions of this Agreement shall be requested in writing by the party desiring such revision, and any such amendments to this Agreement shall be effective by a duly executed amendment hereto.


