The Activity Along the Corridor Summary is a quarterly update of important milestones completed by the various member agencies, counties, and cities of the Grand Boulevard Initiative.

This Summary highlights the most recent activities and complements the Activity Along the Corridor Story Map, an interactive tool that illustrates the cumulative progress that has been made along the El Camino Real Corridor since the inception of the Grand Boulevard Initiative in 2006. The Story Map showcases the locations for public infrastructure and private development projects, as well as planning documents that are in progress, under construction, or completed along the Corridor. CITIES & COUNTIES

Corridor Planning and Development Projects:

In early 2019, the *City of San Mateo* Planning Commission approved the site plan for the construction of a mixed-use building near the downtown Caltrain Station.

The *City of Sunnyvale* continues to work on their El Camino Real Specific Plan. A draft will be available in the fall of 2019.

The *Town of Colma* will be kicking off an El Camino Real study and have selected Fehr and Peers as the consultant.

The *City of San Mateo* is updating their General Plan.

The *City of Santa Clara*'s El Camino Real Draft Plan will be completed late March 2019.

The *City of Belmont* City Council approved Artisan Crossing, a 250-unit apartment building at 1325 Old County Road.

The *City of Palo Alto* is currently seeking input on the North Ventura Coordinated Area Plan and hosting community workshops. The project site is bounded by Page Mill Road, El Camino Real, Lambert Ave and the Caltrain tracks in Palo Alto.

OTHER UPDATES

Grand Boulevard Initiative Website (www.grandboulevard.net)

During the 6 month period of this report (March 2019 to August 2019), the site was visited 1,920 times. New visitors accounted for 91.5% of total people who accessed the site.

Since we began tracking in June 2011, the website has been visited by 47,485 different people (or computers) from over 158 different countries.

Task Force Meeting Summary

March 2019

GBI Creating Safe and Healthy Corridor Communities

Kendra Rowley, Transportation Engineer/Planner at Fehr and Peers, provided an overview of the GBI project titled "Creating Safe and Healthy Corridor Communities". She discussed outreach methods, design concepts, and lessons learned from the project. Funded through a FY16-17 Caltrans Sustainable Transportation Planning Grant, the project facilitated the design of multimodal streetscape improvements to create a roadway that is safe and accessible for all users, is integrated with proposed sustainable development, and enhances modal choices by encouraging pedestrian and transit activity. The project focused on two case study locations on El Camino Real in Redwood City and Palo Alto; the case study locations were selected based on their bicycle and pedestrian collision rates and opportunity to improve roadway safety and downtown connections.

Planning work began in the summer of 2017 and focused on the development of streetscape designs, multimodal performance metrics for measuring the success of the roadway and identifying funding options for cities to consider as they implement the envisioned improvements. The potential designs, tools, outreach methods, and funding and implementation options can be adapted for use in other cities along the El Camino Real Corridor and are documented in the final reports.

Safety on El Camino Real

Brian Oh, Senior Community Health Planner for San Mateo County, and Emma Shlaes, Director of Policy and Advocacy for Silicon Valley Bicycle Coalition (SVBC), presented on Vision Zero and active transportation planning in the El Camino Real Corridor. Based on findings from its 2018 report, <u>Creating Safer</u> <u>Streets Near Schools</u>, the San Mateo County Health System is working closely with SVBC to lead cities in adopting Vision Zero policies. The presentation focused on this collaboration and the challenges and opportunities local jurisdictions face in making their streets safer, especially El Camino Real.

The goal of <u>Vision Zero</u> is to eliminate traffic deaths and life-altering injuries on city streets and roads, and includes the idea that all collisions are preventable,

challenging cities to address safety concerns on their roadways. Analysis of collision reports from the Statewide Integrated Traffic Records System (SWITRS) shows that El Camino Real in San Mateo and Santa Clara counties has a disproportionately high concentration of collisions.
