Electronic device instructions:

For participants who would like to join electronically from a PC, Mac, iPad, iPhone or Android device, please click this URL: <https://sanjoseca.zoom.us/j/96768691667>

Please ensure your device has audio input and output capabilities. During the session, if you would like to comment, please use the “raise hand” feature in Zoom conference call or click *9 to raise hand to speak during public comment.

1. Use a current, up-to-date browser: Chrome 30+, Firefox 27+, Microsoft Edge 12+, Safari 7+. Certain functionality may be disabled in older browsers including Internet Explorer. Mute all other audio before speaking. Using multiple devices can cause an audio feedback.
2. Enter an email address and name. The name will be visible online and will be used to notify you that it is your turn to speak.
3. When the Chair calls for public comment and you wish to speak, click on “raise hand.” Speakers will be notified shortly before they are called to speak.
