#### **Recommendation:**

- (a) Accept the report for a Master Plan for a new park located near the existing culde-sac of Olsen Drive within the Winchester Ranch project development site (555 Winchester Boulevard/APN 303-38-001);

- C. <u>Affordable Housing Parkland Fee Credits for Moderate Income Housing Units;</u> Nicolle Burnham, Deputy Director, PRNS

## **Recommendation:**

- (a) Recommend the City Council amend Chapter 14.25 of Title 14 and Chapter 19.38 of Title 19 of the San José Municipal Code ("SJMC") prescribing new definitions for moderate income units, gross household income for moderate income units, and affordability restrictions related to moderate income units, and to provide that moderate income units shall pay fees set forth in the schedule of parkland fees.
- (b) Recommend the City Council adopt a resolution amending Resolution No. 78474 ("Schedule of Parkland Fees") establishing the parkland fees charged for deed restricted affordable moderate income residential units pursuant to Chapters 14.25 and 19.38 of the SJMC be set at 50% of the applicable parkland fees for each qualifying residential unit type. If approved this credit would expire five years (January 1, 2026), unless otherwise renewed by the City Council.
- D. <u>2020-21 Parks and Recreation Commission Work Plan</u> Recommendation: Recommend approval of the 2020-21 Parks and Recreation Commission Work Plan.
