Meeting Goal: Discuss preliminary project design and provide comments to staff and applicants.

Proposed Projects for Review:

- 1. <u>H20-040 & HP21-001</u>: Site Development Permit and Historic Preservation Permit to allow the demolition of a 15,000 square foot City Landmark building, retaining and integrating the street-facing two story façade and parapet, and the construction of a mixed-use project (25 stories above ground and one basement level) including 37,240 square feet of commercial space and 210 units of senior housing on a 0.22-acre site located at 19 North 2nd Street.
 - a. Provide initial input and feedback on the design of the proposed new infill building involving a designated City Landmark also eligible for listing in the National Register of Historic Places and the California Register of Historical Resources with regard to the Secretary of the Interior's Standards for the Treatment of Historic Properties, and Section 4.2.4 (Historic Adjacency) of the San Jose Downtown Design Guidelines and Standards (2019).
