C. Extension of the Eviction Moratorium through August 31, 2021 for Tenants Financially Impacted by COVID-19 (F. Tran, Housing Department)

ACTION: A) Receive the staff report providing findings that support enacting a temporary moratorium through August 31, 2021 on evictions to protect tenants currently financially-impacted by COVID-19 while the State and local rental assistance programs commence distribution of rental payments to the most vulnerable residents.

- B) Make recommendations to the City Council on whether to adopt an Urgency Ordinance and Companion Ordinance enacting a temporary moratorium on no-cause evictions and evictions due to nonpayment of rent for residential tenants, mobilehome owners and residents, who do the following:
