COVID-19 Recovery Task Force members Dolores Alvarado, CEO of Community Health Partnerships and Kristense Cameron, Policy and Communications Associate with The Health Trust will give a presentation on the prevalence of diabetes, the impact on our community as a whole, and its links to mortality rates among people with COVID-19; community well-being will also be highlighted. It is anticipated that there will be a discussion on solutions and collaboration between the health and other sectors.
