BACKGROUND

As part of the City of San José ("City") oversight of the City's Community Energy Department (also known as San José Clean Energy, "SJCE"), the City prepares annual financial statements audited by an independent auditor, who is retained by the City Council and works under the direction of the City Auditor. Upon Procedures ("AUP"), reviewing SJCE compliance with its Risk Management Regulations as effected October 3, 2019. The City engaged Macias, Gini & O'Connell, LLP ("MGO"), a firm of Certified Public Accountants licensed to practice in the State of California who performs the City-wide annual independent audit, as its independent auditor for these SJCE activities.

ANALYSIS

Unaudited, budget vs. actual revenues and expenditures for the Community Energy Department are posted bi-monthly, in even-numbered months, at <u>https://www.sanjoseca.gov/your-government/departments-offices/office-of-the-city-manager/budget/budget-documents/2020-2021-budget-documents/budget-monitoring</u>. These Bi-Monthly Financial Reports are included on the Public Safety, Finance and Strategic Support Committee Agenda each October, December, April and June. The Budget Office also prepares a detailed Mid-Year Budget Review Report which covers the period July – December and is presented at a City Council meeting each February. Finally, the Budget Office prepares the Annual Report which provides a comparison of actual revenue collections and expenditures to projections and appropriations included in the City's budget. This report is presented to City Council each October along with associated budget adjustments.
