Montgomery Elementary School Holiday Resource Fair will be held on Tuesday, December 17, 2021 at Montgomery Elementary and sponsored by Councilmember Arenas. This special event will support families by providing city and school resources for the community in a fun and festive manner. The event is free and open to the public, and will follow all appropriate local public health rules, including requiring masks and social distancing.
