## **RECOMMENDATION**

- Adopt a resolution authorizing the City Manager or designee to: (a)
  - (1) Accept grant funds from the John S. and James L. Knight Foundation (Knight Foundation) in an amount not to exceed \$750,000 to expand the City's data leadership and capacity to use data to help make decisions, measure outcomes, and drive results that incorporate equity into the planning and delivery of City services: and
  - Negotiate and execute any documents necessary to accept the grant funds. (2)
- Adopt the following 2021-2022 Appropriation Ordinance and Funding Source Resolution (b) Amendments in the General Fund:
  - Increase the estimate for Other Revenue by \$750,000; and (1)
  - Establish the Data Capacity Expansion Project City-Wide Expenses appropriation (2) to the City Manager's Office in the amount of \$750,000.

#### **OUTCOME**

Adoption of the resolution is required to authorize the City Manager to sign the Knight Foundation grant agreement. The grant will provide \$750,000 over a two-year period to the City to expand the expand the City's data leadership and capacity to use data to help make decisions, measure outcomes, and drive results that incorporate equity into the planning and delivery of City services. The Knight grant will leverage the existing funding of \$200,000 in the 2021-2022 Adopted Operating Budget for the Data Equity lead, thereby providing \$950,000 for three years of leadership and capacity-building across the City.

#### **BACKGROUND**

The City of San José continues to focus on having a data driven culture thereby transparently, rigorously, and effectively making decisions, allocating scarce resources to those communities of greatest need, being accountable for the results, and identifying opportunities to improve. The City's focus on equity requires measuring outcomes and driving results with concrete actions towards those outcomes. The Mayor's March Budget Message for Fiscal Year 2021-2022, as approved by the City Council, directed \$200,000 to enable the Administration to hire a data scientist who would assume the role of a City-wide Data Equity Leader to spearhead this work. In the March Budget Message, the possibility of additional grant funding was also indicated.

Building an equity-focused data infrastructure is a necessary component to informing strategies towards improved community outcomes. While leveraging disaggregated demographic data is key to target, drive and measure outcomes in City services and programs, it is just as important to build the skills within the organization to shape and maintain an infrastructure that is accessible and relevant. As the City organization develops its capacity to center equity considerations in decision-making, it has become increasingly important to build a foundation that aligns with racial equity principles: desired impact, disaggregated data, effective community engagement, and accountability. The Data Equity Project will facilitate the process so that outcomes for underserved communities are improved.

#### **ANALYSIS**

The grant funding will cover the periods October 1, 2021 to June 30, 2024 in an amount of \$750,000. The primary funding would support the City to:

- Establish a full-time data science technical lead in the City Manager's Office over a three-year administration-transition period in the city leveraging the initial \$200,000 funding for the Data Equity Lead;
- Train and support City departments to facilitate data collection and analysis for decision making; and
- Support collaboration with other departments in the City including but not limited to the Office of Racial Equity, and the Office of Economic Development and Cultural Affairs, to leverage data to accelerate recovery and build equity.

The City aims to address three core structural challenges around data driven government during this grant:

- Develop a robust, permanent data career track inside the organization that allows for technical data talent to develop their technical skills, problem solving experience, and leadership capabilities;
- Integrate operational data and insights into strategic planning and simulation, policy analysis and recommendations, and community transparency and engagement; and

• Create a model for the City to scout, assess, and - if appropriate and feasible - intelligently procure software, cloud infrastructure and tools, third-party data sources, and other data-related resources that augment the City's data capabilities to create tangible value for residents in an ethical and sustainable manner.

Evaluation reports relating to this grant will be submitted to the Knight Foundation and will include progress on:

- Establishing equity objectives and metrics for core city services and programs;
- Institutionalization of City data equity practices and policies; and
- Increasing data-driven decision-making capacity for City executives and staff.

#### **CONCLUSION**

The grant will provide \$750,000 over a two-year period to the City to expand the expand the City's data leadership and capacity to use data to help make decisions, measure outcomes, and drive results that incorporate equity into the planning and delivery of City services. The Knight grant will leverage the \$200,000 2021-2022 for the Data Equity lead thereby providing \$950,000 in funding for a full three years of leadership and capacity building across the City.

### **EVALUATION AND FOLLOW UP**

The appropriate staff will report to Smart Cities and Service Improvements Committee and other Committees as appropriate on the decisions, outcomes, and results from this project.

#### **CLIMATE SMART SAN JOSE**

Acceptance of the grant would provide the City a total of \$950,000 over a three-year period to expand the City's data leadership and capacity to use data to help make decisions, measure outcomes, and drive results that incorporate equity into the planning and delivery of City services. The Knight Foundation will provide the \$750,000 grant as a lump sum payment after execution of the grant agreement. Remaining funds will be carried over into subsequent years until project completion.
