I am writing you to oppose this ordinance. In reading it, I do not see any provisions to reduce the supposed "gun violence" that San Jose is experiencing. We are one of the only large cities that did not see a huge increase in violent activity. All the data in the body of the ordinance is using numbers from other areas and not San Jose. This does not show that San Jose is experiencing this "dramatic rise".

I am trying to understand who one might support this. Please answer the question to help me. Please do so with an open and honest answer.

1. How will this reduce crime?
2. Do you expect those that already that are prohibited from owning a gun to pay this?
3. Does any insurance company issue this insurance?
4. Do you expect people not to leave the city to not pay this tax?

5. Why the exemptions? In the ordinance it mentions "same as car insurance". There are no exemptions there for low income.

6. Will the Chief of Police start issuing CCW permits to be able to apply for the waiver? If no, then why?

The ordinance mentions in the findings item 8 that the insurance companies incentivized for the use of airbags. This is not entirely true as this was mandated by the NTSB. Also car insurance is NOT mandatory to own a vehicle. It is only required if that vehicle is to be used on public roads. And to that end all that is required is to cover your fault accidents. You can also add onto your auto policy cover to cover other peoples damage if their coverage is not enough. So with this if you can find an insurance company to offer any of this coverage are you then going to encourage non gun owner to get this coverage in case they are accidently shot?

The last question for this is do you not expect California Rifle & Pistol Assn, Gun Owners of California, Second Amendment Foundation and the NRA to file suit against this? They will most likely win this in court and then the City will be paying all the court cost and the money wasted trying to defend this. Would that money not be better spent on other things the City desperately needs?
